# INDEX TO GUIDELINES MANUAL

This index provides an alphabetical list of topics addressed in the Guidelines Manual and refers the reader to provisions that may be relevant to those topics. This index is unofficial and is provided only as a convenience to the reader.

Note that this index generally does not refer the reader to provisions in Chapter Two offense guidelines. This is by design, because this index is not to be used in determining the offense guideline section in Chapter Two (Offense Conduct) that applies in a particular case. Such determinations are made based on the statute of conviction. See §1B1.2 (Applicable Guidelines) and Appendix A (Statutory Index).

For example, this index contains an entry for "kidnapping" which refers the reader to the Chapter Three adjustment at §3A1.3 (Restraint of Victim) and the upward departure provision at §5K2.4 (Abduction or Unlawful Restraint), each of which may be relevant to kidnapping. This index does not, however, refer the reader to any of the Chapter Two offense guidelines with provisions that may be relevant to kidnapping. The Chapter Two offense guideline that applies in a case involving a kidnapping is determined by identifying the statute of conviction and consulting §1B1.2 (Applicable Guidelines) and Appendix A (Statutory Index).
