Of these, 18,195 were sentenced under §§2D1.1 (Drug Trafficking), 2D1.2 (Protected Locations), 2D1.5 (Continuing Criminal Enterprise), 2D1.6 (Communication Facility), 2D1.8 (Rent/Manage Drug Establishment), or 2D2.1 (Simple Possession). Of these 18,195 cases, 10 were excluded due to one or both of the following reasons: missing mandatory minimum information (0) or missing drug type (10).
