For the 'As Any Guideline' section, each unique guideline is only counted once in a case. Descriptions of variables used in this table are provided in Appendix A.

<sup>2</sup> In 1,069 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 1028A. By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 1,069 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.

<sup>3</sup> In 2,108 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 924(c). By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 2,108 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.
