¹ Of the 7,868 appeals cases, 2,961 were excluded due to one of the following reasons: type of appeal was "conviction only" (1,441), "Anders Brief" (1,460), or "unknown" (60). Of the 4,907 remaining cases, 4,886 were excluded due to one or more of the following reasons: the appeal was by the defendant only (4,877), the appeal was of an issue related to a post sentencing matter (1,047), and/or the appeal was of a sentence imposed upon the revocation of probation or supervised release (433). Descriptions of variables used in this table are provided in Appendix A.

² "Remanded" includes cases that were remanded for sentencing purposes.
