In addition, 1,009 cases were excluded due to one or both of the following reasons: missing Criminal History Category (548) or missing or indeterminable sentencing information (524). Sentences of 470 months or greater (including life) were included in the sentence average computations as 470 months. The information in this table does not include conditions of confinement as described in USSG §5C1.1. Descriptions of variables used in this table are provided in Appendix A.
