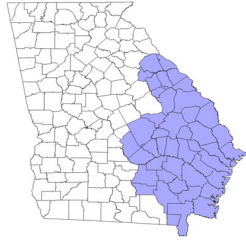


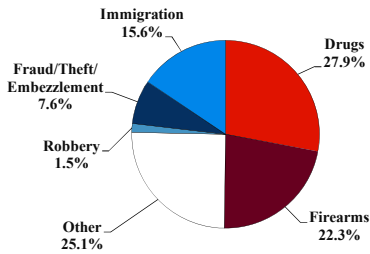

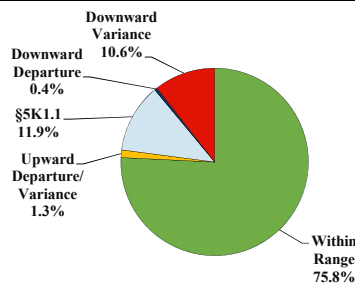
### Fiscal Year 2018

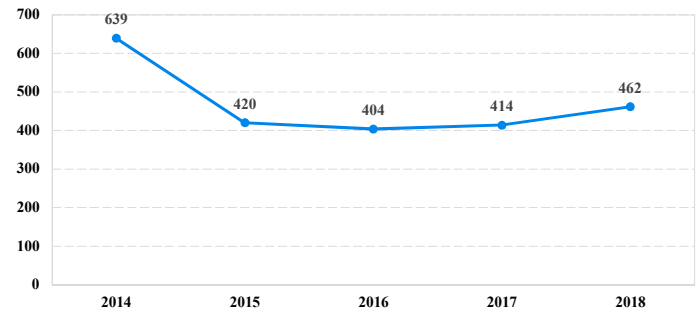

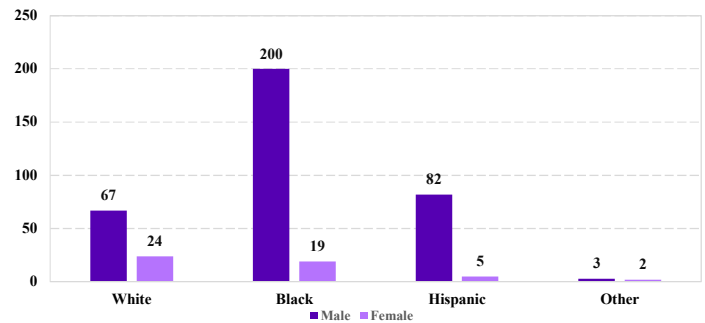
