

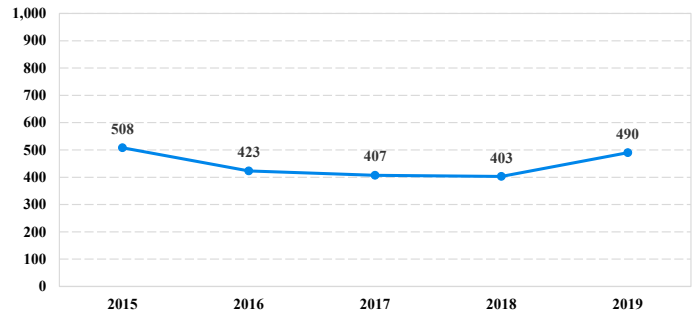

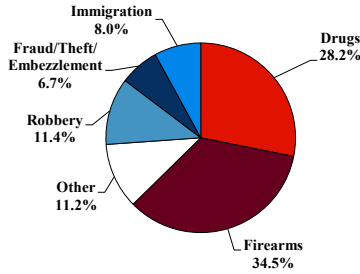
### Fiscal Year 2019



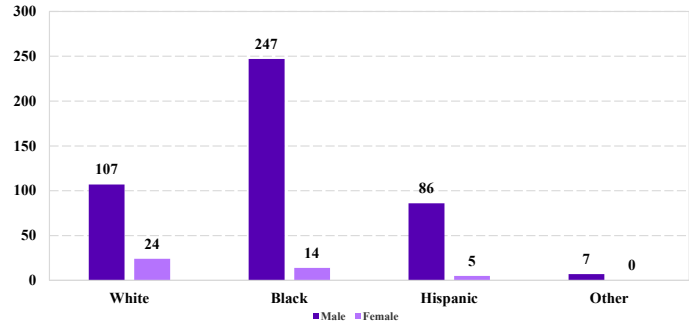
Number of Federal Offenders Over Time



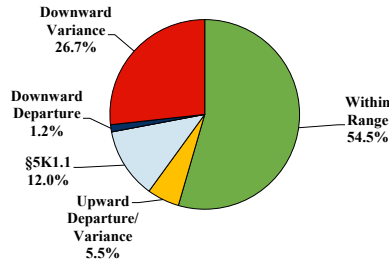
#### Type of Crime



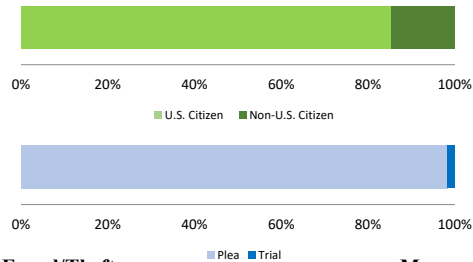
