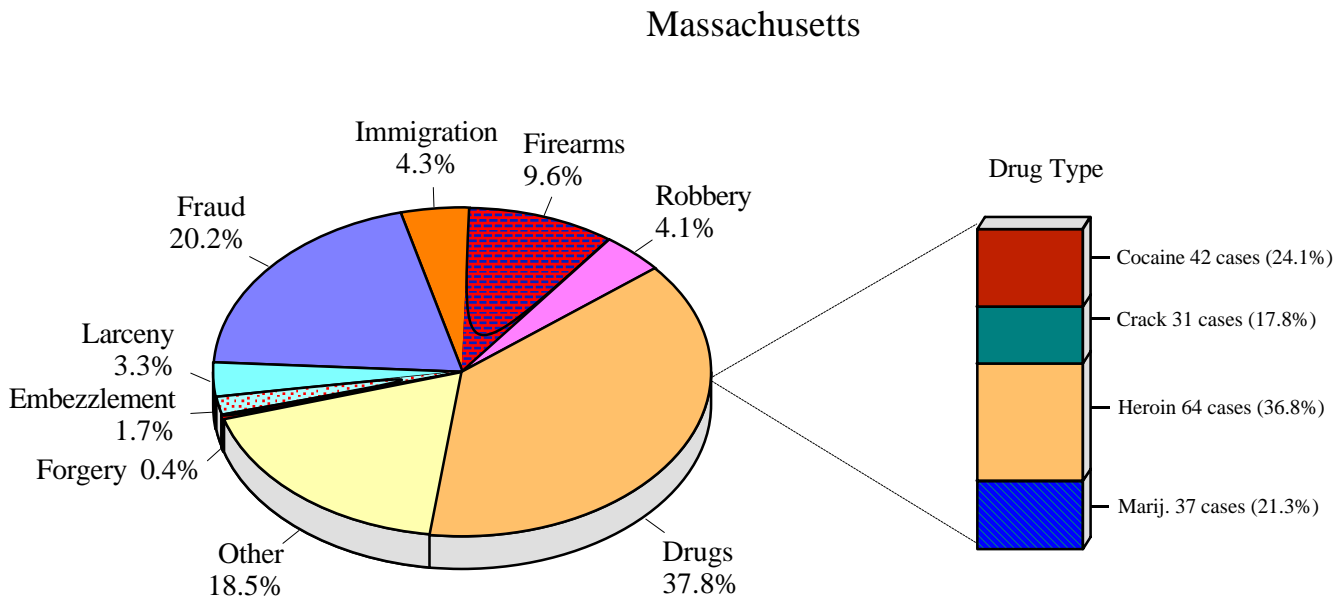
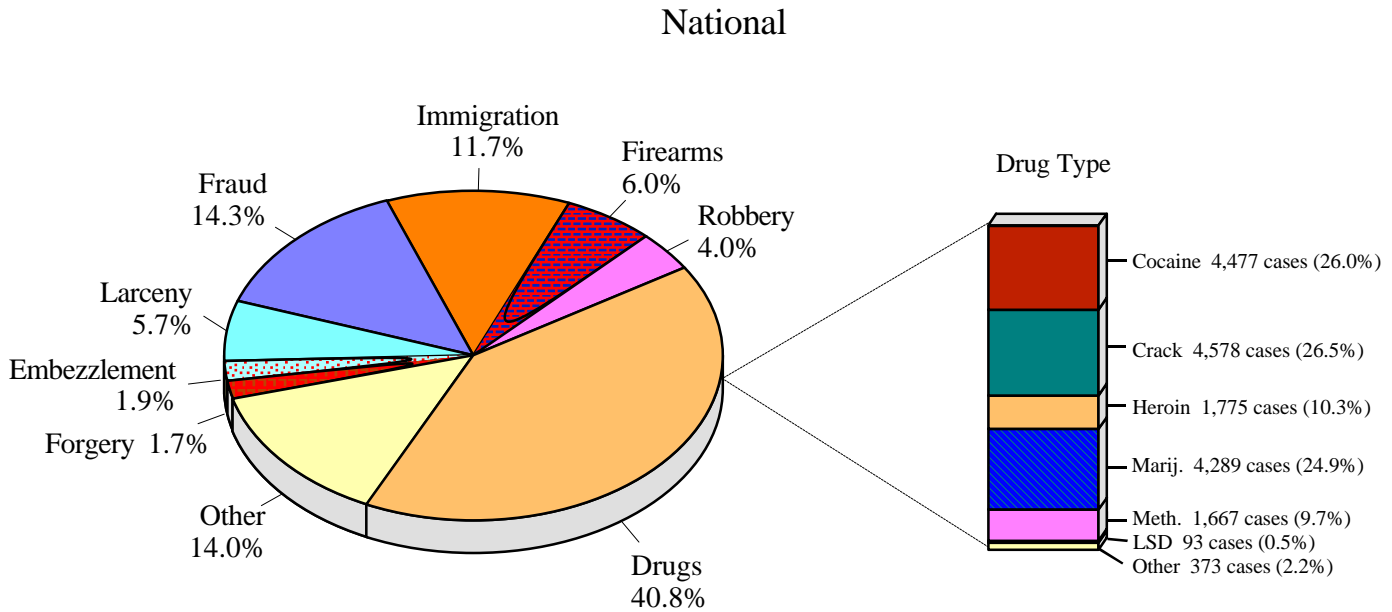

Of the 42,436 guideline cases, 8,615 cases with zero months prison ordered were excluded. In addition, 370 cases were excluded due to one or both of the following reasons: missing primary offense category (74) or missing or indeterminable sentencing information (330).

Of the 461 guideline cases from the District of Massachusetts, 110 cases with zero months prison ordered were excluded. In addition, 6 cases were excluded due to one or both of the following reasons: missing primary offense category (1) or missing or indeterminable sentencing information (6).
