


Figure A DISTRIBUTION OF SENTENCED GUIDELINE OFFENDERS BY SELECT

Of the 18,203 guideline cases, 46 cases with no analogous guidelines were excluded from the table. Of the remaining 18,157 cases, 1,365 were excluded due to missing departure information.
