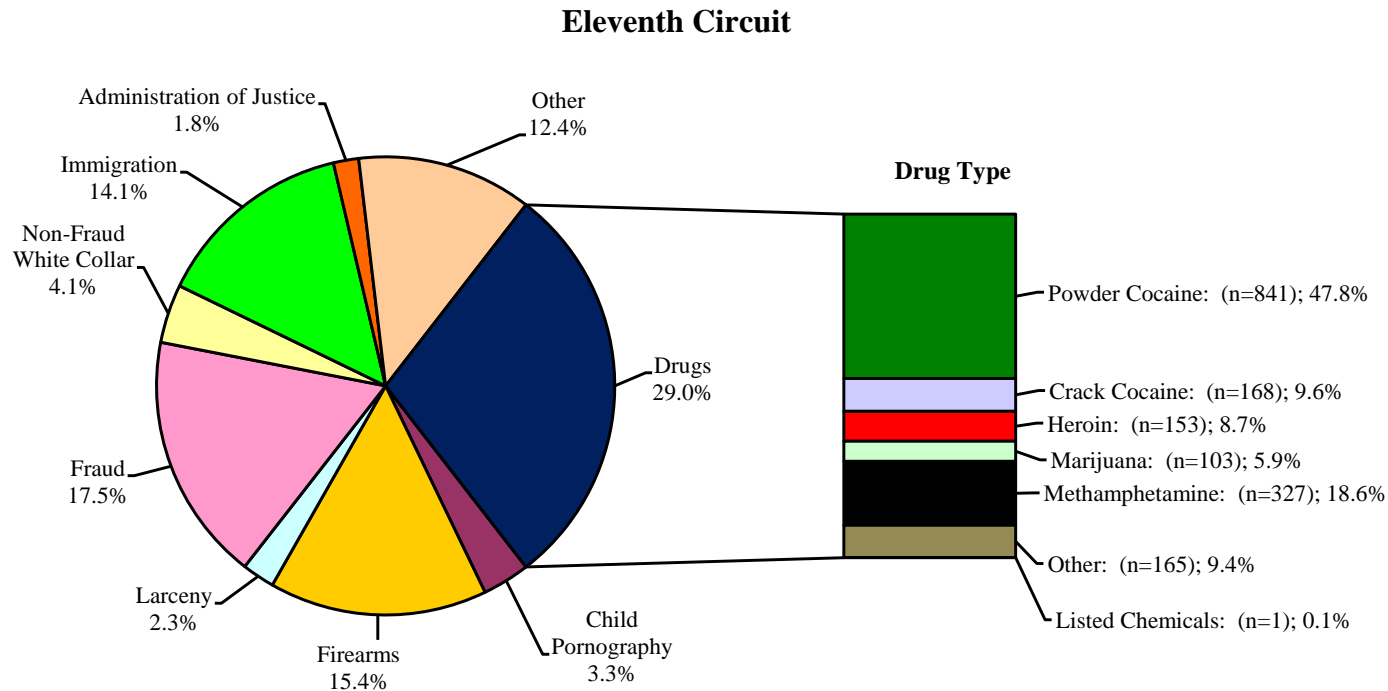
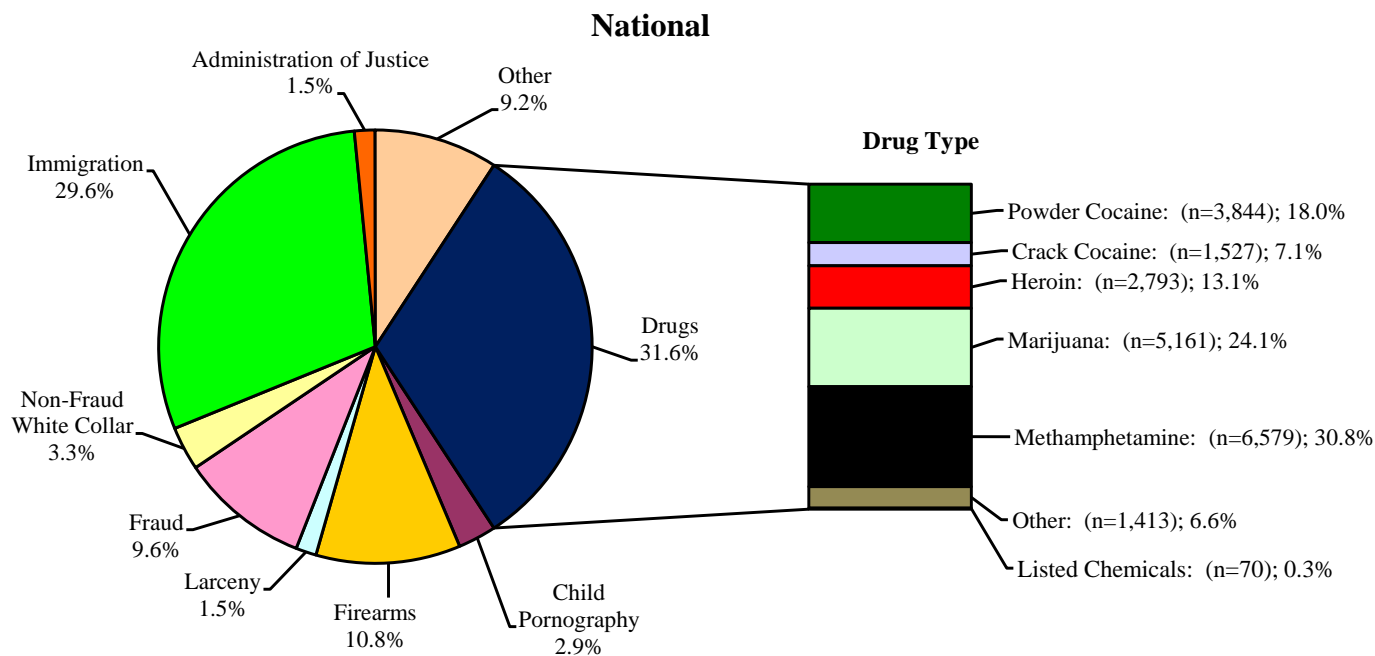

Of the 6,060 guideline cases from the Eleventh Circuit, 106 cases were excluded because information was missing from the from the submitted documents that prevented the comparison of the sentence and the guideline range.
