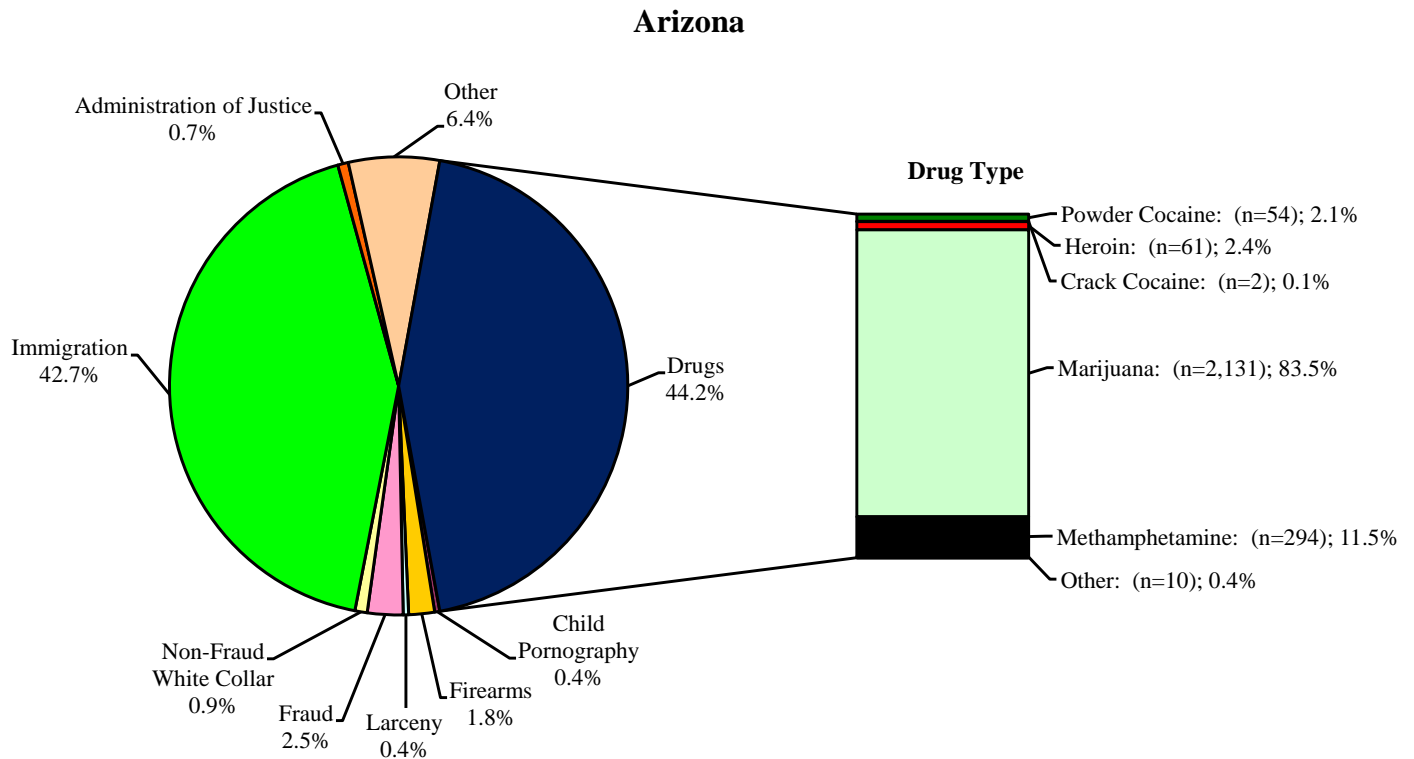
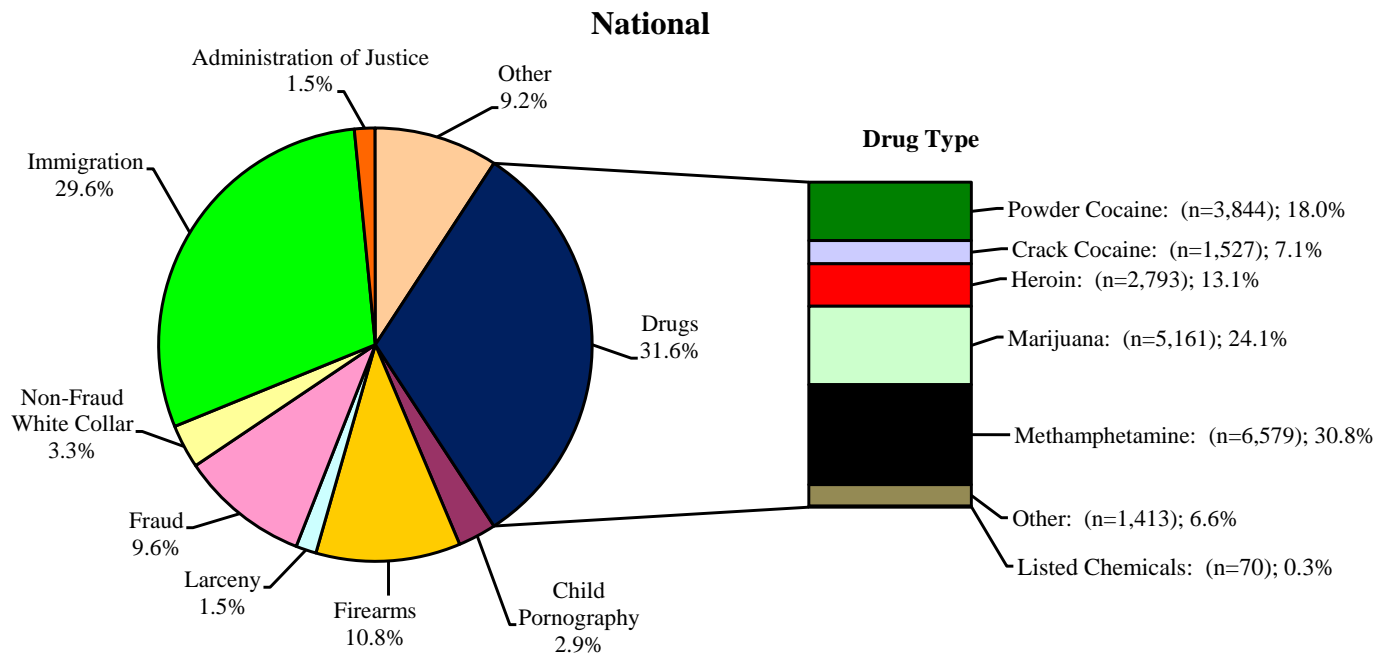

Of the 5,769 guideline cases from the District of Arizona, a U.S. Citizen was the defendant in 1,344 cases. Of these, 1,022 cases were excluded because the defendant was ineligible for a non-prison sentence.
