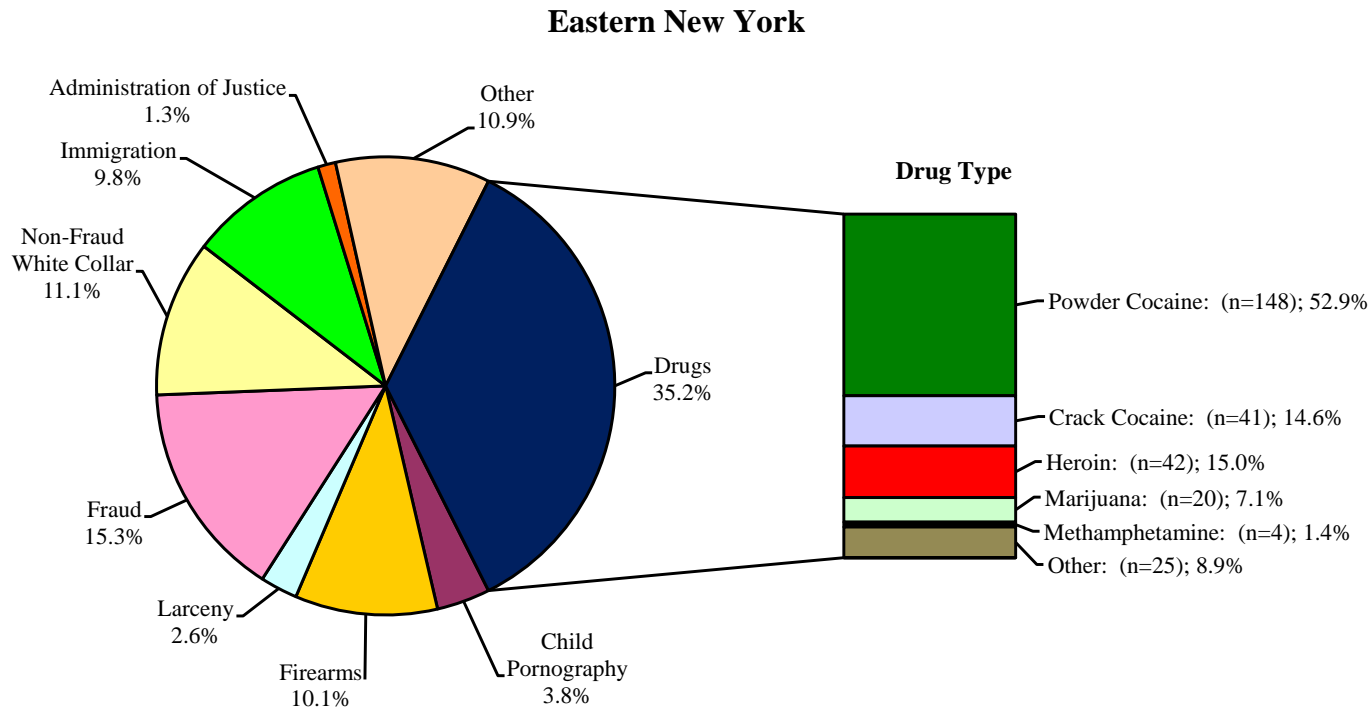

Of the 67,742 guideline cases, 781 cases were excluded because information was missing from the submitted documents that prevented the comparison of the sentence and the guideline range.

Of the 796 guideline cases from the Eastern District of New York, no cases were excluded.
