
Fiscal Year 2021

- IN FY 2021, 57,287 CASES WERE REPORTED TO THE U.S. SENTENCING COMMISSION.
 - 17,692 CASES INVOLVED DRUGS.¹
 - 17,520 INVOLVED DRUG TRAFFICKING.²
 - 48.3% OF DRUG TRAFFICKING CASES INVOLVED METHAMPHETAMINE.
 - METHAMPHETAMINE TRAFFICKING OFFENDERS HAVE INCREASED BY 17.2% SINCE FY 2017.

Sentence Length FY 2021




Offender and Offense Characteristics³

- 76.9% of methamphetamine trafficking offenders were men.
- 41.9% were Hispanic, 38.8% were White, 15.0% were Black, and 4.3% were Other races.
- Their average age was 37 years.
- 86.8% were United States citizens.
- 37.3% had little or no prior criminal history (Criminal History Category I); 5.7% were career offenders (§4B1.1).
- The median base offense level in these cases was 32, corresponding to between 1.5 and five kilograms of methamphetamine mixture or 150 and 500 grams of methamphetamine actual/"ICE."
- Sentences were increased for:
 - possessing a weapon (26.1%);
 - a leadership or supervisory role in the offense (4.7%).
- Sentences were decreased for:
 - minor or minimal participation in the offense (24.3%);
 - meeting the safety valve criteria in the sentencing guidelines (37.4%).
- The top five districts for methamphetamine trafficking offenders were:
 - Southern District of California (1,215);
 - Western District of Texas (514);
 - Northern District of Texas (403);
 - Southern District of Texas (323);
 - District of Arizona (306).

Punishment

- The average sentence for methamphetamine trafficking offenders was 90 months.
- 98.4% were sentenced to prison.
- 80.4% were convicted of an offense carrying a mandatory • minimum penalty; of those offenders, 57.6% were relieved of that penalty.




Methamphetamine Trafficking Offenses


Sentences Relative to the Guideline Range

- Of the 65.5% of methamphetamine trafficking offenders sentenced under the Guidelines Manual:
 - 36.4% were sentenced within the guideline range.
 - 33.8% received a substantial assistance departure.
 Their average sentence reduction was 48.4%.
 - 21.9% received an Early Disposition Program (EDP) departure.⁴
 Their average sentence reduction was 66.6%.
- 34.5% received a variance; of those offenders:
 - 98.6% received a downward variance.
 Their average sentence reduction was 35.3%.
 - 1.4% received an upward variance.
 Their average sentence increase was 45.2%.
- The average guideline minimum increased and the average sentence imposed fluctuated over the past five years.
 - The average guideline minimum increased from 123 months in fiscal year 2017 to 131 months in fiscal year 2021.
 - The average sentence imposed increased and decreased throughout the fiscal years. The averages sentence was 88 months in fiscal year 2017 and 90 months in fiscal year 2021.

¹ Drug offenses include cases where offenders were sentenced under USSG Chapter Two, Part D (Drugs). There were 8,494 methamphetamine offenders sentenced under USSG Chapter Two, Part D (Drugs) in FY 2021.

² Drug Trafficking offenders were sentenced under USSG §§2D1.1 (Drug Trafficking), 2D1.2 (Protected Locations), 2D1.5 (Continuing Criminal Enterprise), 2D1.6 (Use of a Communication Facility), 2D1.8 (Rent/Manage Drug Establishment), 2D1.10 (Endangering Human Life), or 2D1.14 (Narco-Terrorism).

 $^{\scriptscriptstyle 3}$ Cases with incomplete sentencing information were excluded from analysis.

⁴ "Early Disposition Program (or EDP) departures" are departures where the government sought a sentence below the guideline range because the defendant participated in the government's Early Disposition Program, through which cases are resolved in an expedited manner. See USSG §5K3.1.
