§4C1.1 First Offender

(a) A defendant is a first offender if [(1) the defendant did not receive any criminal history points from Chapter Four, Part A, and (2)] the defendant has no prior convictions of any kind.




FY14 Criminal History Sample

- Ten percent representative sample
 - Offenders sentenced in FY14
 - Cases randomly sampled from each of 94 federal judicial districts
 - Complete sentencing documentation
- Details of sentencing events from Presentence Reports
 - Number and types of offenses
 - Relevant Chapter 4 provision applied
 - Points assigned under Chapter 4 of the guidelines




Four Categories of CHC I Offenders FY14 Criminal History Sample

(a) A defendant is a first offender if [(1) the defendant did not receive any criminal history points from Chapter Four, Part A, and (2)] the defendant has no prior convictions of any kind.



(b) If the defendant is determined to be a first offender under subsection (a), decrease the offense level determined under Chapters Two and Three by **[1]** level.






[Option 2:

(b) If the defendant is determined to be a first offender under subsection (a), decrease the offense level as follows:

(1) if the offense level determined under Chapters Two and Three is less than level **[16]**, decrease by **[2]** levels; or


(2) if the offense level determined under Chapters Two and Three level **[16]** or greater, decrease by **[1]** level.]

First Offenders in Each Final Offense Level Extrapolated from FY14 Criminal History Sample



Comparison of First Offenders Impacted by Proposed Amendment Sentence Relative to the Guideline Range FY14 Criminal History Sample






Recidivism of CHC I Offenders

Recidivism of CHC I Offenders Released in CY05

- Data from Commission's ongoing recidivism work
 - Recidivism Among Federal Offenders: A Comprehensive Overview (March, 2016)
 - 25,431 U.S. citizen offenders released from prison or sentenced to probation in calendar year 2005
 - Eight year follow-up period
 - Three measures of recidivism
 - Rearrest
 - Reconviction
 - Reincarceration

Part B

Consolidation of Zones B and C in the Sentencing Table

- Expands Zone B by consolidating Zones B and C in the Sentencing Table
 - Expanded Zone B would include sentencing ranges with guideline minimums as low as one month and guideline maximums up to 18 months
 - Allow for existing Zone B sentencing options
- Offenders Sentenced in FY15




Current Confinement Options for Each Sentencing Table Zone ²⁴

Zone	Confinement Ranges	Within Range Sentencing Options
Zone A	0-6 months	 Probation only Probation with a confinement condition Split sentence Imprisonment
Zone B	From 1-7 to 9-15 months	 Probation substituted for confinement provided the term includes confinement conditions Imprisonment - If imposed a minimum of one month must be imprisonment. Remainder of sentence may be imprisonment or a substitution of probation that includes home detention or community confinement.
Zone C	From 10-16 to 12-18 months	 Must include imprisonment term equivalent to at least half of the minimum of the applicable guideline range. Remainder of term requires supervised release with a condition of confinement. Imprisonment
Zone D	From 15-21 months to life	• Imprisonment


