<sup>1</sup>Of the 18,203 cases, 352 were excluded due to one or both of the following reasons: missing primary offense category (29) or missing information on type of economic sanction for cases in which orders were made (333). The total number of cases (4,280) used to calculate amounts of payment ordered is less than the total number of cases receiving fines and/or restitution (4,284) due to the exclusion of cases for which a fine and/or restitution was ordered, but the amount was not specified. Fine information includes either fines and/or the cost of supervision. Descriptions of variables used in this table are provided in Appendix A

<sup>2</sup>In cases of joint and several restitution the full amount of restitution is attributed to each offender which may result in overinflation of the total amount of restitution reported for all offenders.
