The total for any guideline can exceed that for primary guideline because several guidelines may be applied in a case, but only one primary guideline. Descriptions of variables used in this table are provided in Appendix A.

<sup>2</sup>In 935 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 1028A. By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 935 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.

<sup>3</sup>In 2,499 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 924(c). By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 2,499 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.
