¹ Of the 86,201 cases, 8,695 were excluded due to missing guideline applied. The total for any guideline can exceed that for primary guideline because several guidelines may be applied in a case, but only one primary guideline. Descriptions of variables used in this table are provided in Appendix A.

² In 834 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 1028A. By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 834 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.

³ In 2,366 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 924(c). By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 2,366 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.
