² In 1,020 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 1028A. By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 1,020 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.

³ In 2,184 cases, the defendant was convicted of one or more counts of violating 18 U.S.C. § 924(c). By statute, the punishment for this crime must be served consecutively to any other punishment, therefore, in these 2,184 cases the conviction for this crime did not affect the guideline calculation for the underlying offense.
