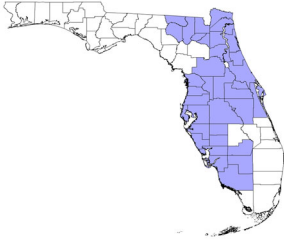


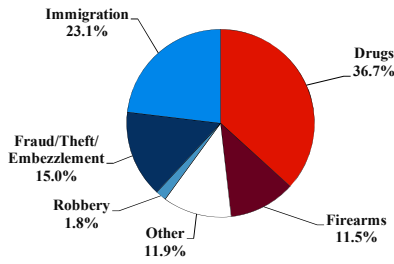

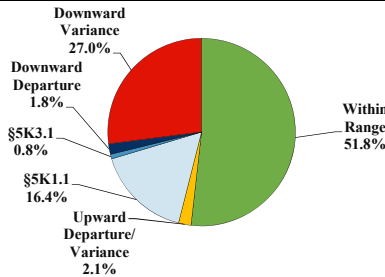

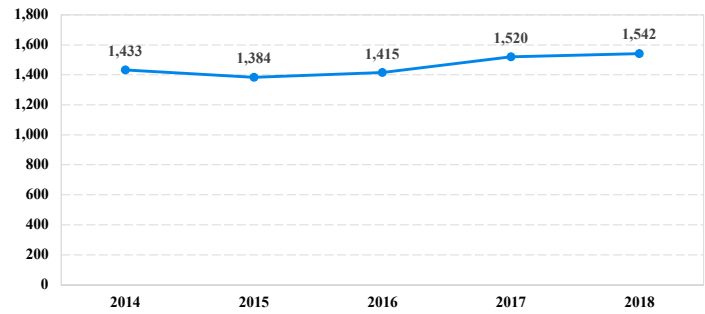

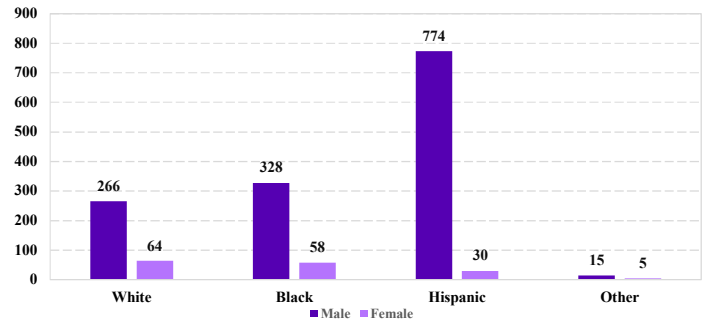

Cases in the Total Receiving Prison and Total Receiving Probation categories total 100 percent of all cases.
