






#### Sentence Imposed Relative to the Guideline Range



Cases in the Total Receiving Prison and Total Receiving Probation categories total 100 percent of all cases. Cases missing information required for a specific analysis were excluded from that analysis. Descriptions of variables used in this analysis are provided in Appendix A.
