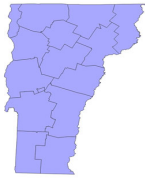


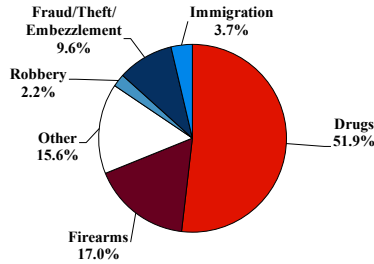

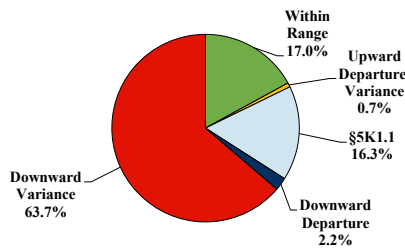
### Fiscal Year 2022



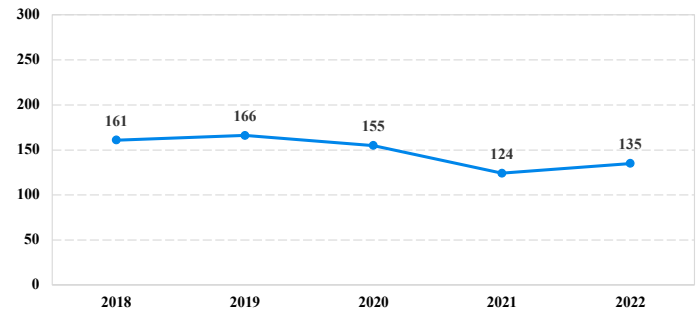
#### Type of Crime



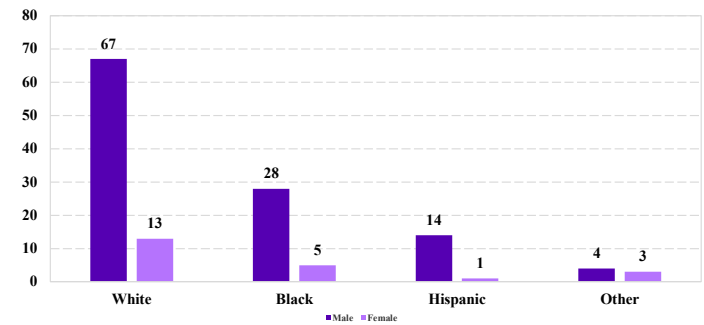
#### Sentence Imposed Relative to the Guideline Range



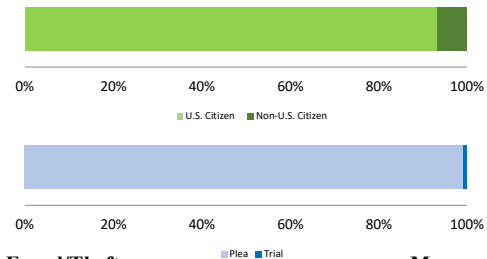
#### Number of Federal Offenders Over Time
