<sup>1</sup> Of the 64,124 cases, in 19,232 the sentence was a variance below the guideline range. Courts may cite multiple reasons for sentencing outside the guideline range; consequently, the total number of reasons cited generally exceeds the total number of cases. In this table, 102,513 reasons were cited for the 19,232 cases. The 'Other' category includes all reasons cited fewer than 515 times among relevant cases and 999 cases where the Statement of Reason was received, but there was insufficient documentation provided to determine some of the reasons for the sentence. Descriptions of the variables used in this table are provided in Appendix A.
