

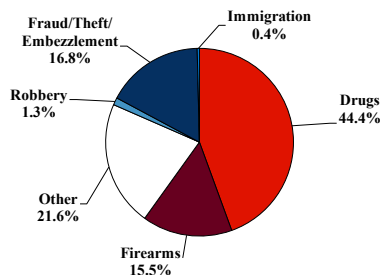

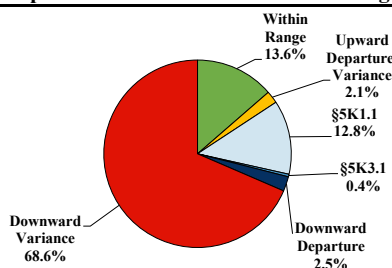
### Fiscal Year 2024



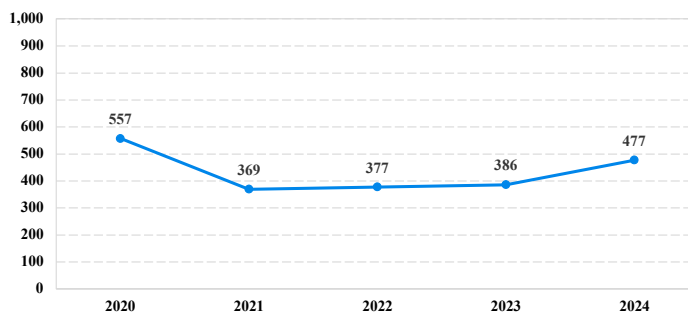
#### Type of Crime



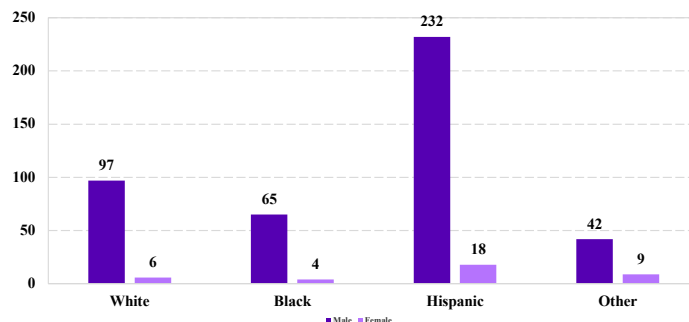
#### Sentence Imposed Relative to the Guideline Range



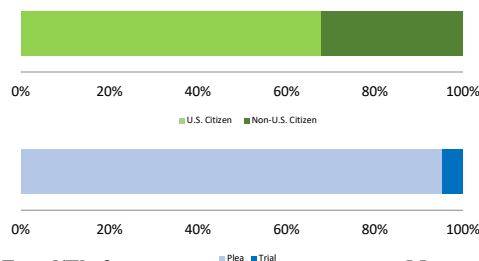
#### Number of Sentenced Individuals Over Time
