

## Production Child Pornography Offenses

In 2021, the United States Sentencing Commission issued two reports, which analyze fiscal year 2019 data to update and expand upon the Commission's 2012 report to the Congress on federal child pornography offenses. The reports separately analyze non-production and production child pornography offenses.

These reports are intended to provide updates to Congress, judges, and other stakeholders on the behavior and sentencing of child pornography offenders.



## §2G2.1 Offenders

Although child pornography production cases comprise a small percentage of the overall federal caseload, the expansion of digital and mobile technology has contributed to a 422% increase in the number of production offenders sentenced over a 15-year period, from 98 offenders in FY 2005 to 512 offenders in FY 2019.



The rate of within-range sentences for production offenders has decreased since FY 2005, from 83.3% to 30.7% in FY 2019. Despite the low within-range rate, the serious nature of these offenses generally leads to lengthy sentences of 23 years on average.

On average, longer sentences in excess of 300 months were imposed for offenders who:

- victimized infants or toddlers;
- were parents of victims;
- engaged in or facilitated the sexual contact of a minor during the offense; or
- incapacitated victims



Sentence lengths vary based on the presence of aggravating factors relating to the offenders' proximity to the victim, participation in the offense, and propensity to engage in exploitive behavior.







**Propensity**

More than two-thirds of child pornography production offenders also engaged in additional child pornography conduct or sexual exploitation.
