



### **Overall Trends in Prison Contraband Offenses**




#### Number of Cases Sentenced Under §2P1.2 Over Time Fiscal Years 2019 through 2023





#### Distribution of §2P1.2 Cases by Circuit






#### All Prison Contraband Type of Sentenced Individual





#### All Prison Contraband Smuggling Method
















#### Cell Phone Prison Contraband Type of Sentenced Individual





#### Cell Phone Contraband Smuggling Method
















#### Prison Contraband Drug Type





#### Drug Contraband Type of Sentenced Individual







#### Drug Contraband Surveillance Type












#### Prison Contraband Weapon Type

#### Weapon Contraband Type of Sentenced Individual










#### Weapon Contraband Facility Type




#### Prison Contraband Criminal History Category
