





Career Offender Directive

28 U.S.C. § 994(h)

“The Commission shall assure that the guidelines specify a sentence . . . at or near the [statutory] maximum” when an adult is:



Career Offender Guideline

U.S.S.G. §4B1.1(a)

An enhancement under §4B1.1 applies if:

- 1 the defendant was at least eighteen years old at the time the defendant committed the instant offense of conviction;
- 2 the instant offense of conviction is a felony that is either a crime of violence or a controlled substance offense; and
- 3 the defendant has at least two prior felony convictions of either a crime of violence or a controlled substance offense.

Career Offender Guideline

U.S.S.G. §4B1.1(b)

Offense Statutory Maximum	Offense Level
Life	37
25 years or more	34
20 years or more, but less than 25 years	32
15 years or more, but less than 20 years	29
10 years or more, but less than 15 years	24
5 years or more, but less than 10 years	17
More than 1 year, but less than 5 years	12


If §4B1.1 applies, the criminal history category shall be Category VI.

Fiscal Years 2015 - 2024







Sentence Imposed Relative to the Guideline Range for Individuals Sentenced under §4B1.1 Career Offender

Fiscal Year 2024




Sentence Imposed Relative to the Guideline Range for Individuals Sentenced under §4B1.1 Career Offender



Distribution of Prior Offenses Scored under §4A1.1


