INTRODUCTION

This codebook is for the U.S. Sentencing Commission's analysis datafiles used for the report *Federal Armed Career Criminals: Prevalence, Patterns, and Pathways*. The report included analyses of offenders sentenced as armed career criminals between fiscal years 2010 and 2019. The report also included analyses of the recidivism of armed career criminals released into the community between 2009 and 2011.

Two analysis datafiles were used for the report: 1) a fiscal year 2019 datafile (USSC_ACCAFY19_Public) and 2) a fiscal year 2010-2019 datafile (USSC_ACCA10yr_Public). Each datafile includes the variables used for the report. The datafiles include variables from the Commission's fiscal year 2010-2019 individual offender datafiles. Variables from the individual offender datafiles are identified as "USSCFY Datafiles" in the ORIGIN column in the codebook. Additional information for these variables can be found in: *Variable Codebook for Individual Offenders: Standardized Research Data Documentation for Fiscal Years 1999-2021* at www.ussc.gov/research/datafiles/commission-datafiles#individual. The analysis datafiles also include recodes of variables from the Commission's individual offender and criminal history datafiles. These variables are identified as "ACCA" in the ORIGIN column in the codebook. Additional information for variables from the criminal history datafile can be found in: *Variable Codebook for Criminal History Datafile* at ussc.gov.

The DATAFILE column in the codebook indicates the variables contained in each datafile: "ACCA FY19" indicates variables in the fiscal year 2019 datafile and "ACCA 10YR" indicates variables in the fiscal year 2010-2019 datafile. Each datafile was restricted to cases for which complete sentencing documentation was received by the Commission.

The recidivism analysis in the report included information obtained pursuant to an interagency agreement with the Federal Bureau of Investigation. That agreement prohibits the Commission from releasing the data.
