UNITED STATES SENTENCING COMMISSION

VARIABLE CODEBOOK FOR COMPASSIONATE RELEASE: THE IMPACT OF THE FIRST STEP ACT AND COVID-19 PANDEMIC



Introduction

The United States Sentencing Commission is an independent agency in the judicial branch of government. Its principal purposes are: (1) to establish sentencing policies and practices for the federal courts, including guidelines to be consulted regarding the appropriate form and severity of punishment for offenders convicted of federal crimes; (2) to advise and assist Congress and the executive branch in the development of effective and efficient crime policy; and (3) to collect, analyze, research, and distribute a broad array of information on federal crime and sentencing issues, serving as an information resource for Congress, the executive branch, the courts, criminal justice practitioners, the academic community, and the public.

Section 3582(c)(1)(A) of title 18 of the United States Code (commonly referred to as the "compassionate release" provision) authorizes a court to reduce a defendant's term of imprisonment for "extraordinary and compelling" reasons. As part of its annual data collection processes, the Commission receives sentencing documents for any sentence modifications, including sentence reductions granted pursuant to 18 U.S.C. § 3582(c)(1)(A). This codebook discusses the data available in the Commission's Compassionate Release Publication datafile. The Commission released a report using this data in March 2022 (see Compassionate Release: The Impact of the First Step Act and COVID-19 Pandemic at www.USSC.gov) (hereinafter the "Compassionate Release Publication"). Most grants of compassionate release included in the report were identified in the court documents submitted to the Commission through its standard document collection process. The Commission identified most denials of compassionate release, and a small number of additional grants, through a separate process described in the methodology section of the Compassionate Release publication.

The Commission conducted a special coding project to collect the reasons courts cited for granting or denying compassionate release and, for offenders granted relief, additional information about the nature of the relief received. The study group for this special coding project included all 1,805 offenders who were granted compassionate release in fiscal year 2020 ("Offenders Granted Relief") and a 40 percent proportionate stratified random sample (n=2,028) of the 5,209 offenders whose motion for compassionate release was denied in fiscal year 2020 ("Offenders Denied Relief"). To reflect the changes over the course of the year, the denial sample included 40 percent of offenders denied compassionate release during each month of the study period. For additional information about case selection/inclusion, please see the methodology section of the Commission's Compassionate Release Publication.

There are two data selections used in this report: 1) basic data on all offenders whose motion for compassionate release was decided in fiscal year 2020, which are variables collected on an ongoing basis for the Commission's compassionate release datafile; 2) special publication coding data, which are the coding variables for the Offenders Granted Release and the Offenders Denied Release sample collected only for the Compassionate Release Publication. Please see the variable INREPORT (p.7) of this codebook to limit data selection to the Offenders Granted Release and the Offenders Denied Release sample. Note that due to the special coding efforts, the data presented in the Compassionate Release Publication may differ from the on-going data reports released by the Commission (*see* Compassionate Release Data Reports at ussc.gov).

How to Use the Compassionate Release Codebook

The first column in the codebook, NAME, lists the name of each variable in alphabetical order. Under the variable names, the corresponding research variable name (if one exists) will be listed as: R=Research variable name. The research variables are generally those used in the Commission's publications such as the *Sourcebook of Federal Sentencing Statistics*.

The second column, FORMAT, describes whether the variable is coded as numeric (NUM), character (CHAR), or date (DATE). This column also lists the length of each variable.

The third column, VALUES, lists all the values for each variable and describes what those values mean. Some of the variables have a large number of values, so these values are listed in Appendix B at the end of the codebook.

The final column, DESCRIPTION, describes the uses and creation of each variable. This column also contains notes which caution users about variables which have changed definitions from previous years, or not contained on all years of the data sets.

Attachments have been included at the back of the codebook to elaborate on variable information. Appendix A discusses the calculation of time-served and reduction. Appendix B provides details for variables with a larger number of values.

APPENDIX A

Additional Information About Sentences, Time Served, and Amount of Reduction

Offenders who applied for compassionate release all had an original federal sentencing that had occurred prior to the compassionate release request. The original sentence length and the original type of crime are used for reporting purposes in Figures 10-13 in the Compassionate Release Publication.

When an offender was granted compassionate release, the judge took one of the follow actions: imposed a prison sentence that was a reduction in the offender's current sentence, but which required the offender to remain in prison to continue serving the remaining time on the sentence; imposed a sentence of alternative confinement (generally home detention) to be served; or imposed a sentence of "time served," which resulted in the release of the offender.

The type of compassionate release sentence (CRSENTYPE) was determined as follows:

- If the judge imposed a prison sentence in months/specified an amount of time left to be served in months, or if the time imposed was greater than 21 days, then the sentence type was categorized as "time imposed". Note that the requirement that a sentence be more than 21 days for this category was decided based on the large number of cases where the offender's release was delayed for 2-3 weeks for a quarantine period prior to release. In those cases, the stay of up to 21-days was not intended to be a new sentence.
- If the judge imposed no prison time in months (but may have imposed prison time up to 21 days), and at least one form of alternative confinement (home detention, intermittent confinement, or community confinement) was imposed, then the type of sentence was categorized as "alternative confinement".
- If an offender received a prison sentence of 21 days or less (and no months) and no alternative confinement, then the type of sentence was categorized as "time served."

The difference between the offender's original sentence date and the compassionate release decision date was used to determine the time served amount in months (TSERVEDM). Some offenders were resentenced or received a modification of sentence (for reasons other than compassionate release) prior to the compassionate release decision. If so, the newer sentence was used for the purposes of calculating the amount of time served. If an offender had been released from his/her original sentence and was subsequently incarcerated based on a probation violation or supervised release violation, then the violation sentence and violation sentence date were used for the time served calculation.

In some cases, offenders had more than one federal conviction (resulting in two or more separate sentencings) or had both federal and state sentences. In other cases, the exact date when the offender began serving time for the "instant" federal offense could not be determined. In all these situations, the amount of time served is missing.

The percent of the time served (TSERVEDP) was calculated by dividing the time served by the violation sentence, or the latest sentence due to a re-sentencing or modification of sentence if the offender was still in prison, or the original sentence if the offender had not received a new

sentence via a re-sentencing, and then multiplying by 100. Cases where the time served amount was missing or the most recent sentence was "life" were excluded from calculations.

The amount of reduction in months (REDUCTM) was calculated from the most recent sentence (violation, re-sentence, or original). For the time-imposed cases (i.e., those offenders who had reduced sentences, but still had to serve time in prison), the reduction was calculated based on the most recent sentence minus the time-imposed amount. For cases where an alternative sentence was imposed, the formula to determine the amount of reduction was the most current sentence minus the time imposed and then the amount of time served was subtracted from that result. For cases where a "time served" sentence was imposed, the formula to calculate the amount of reduction was the most recent sentence minus the amount of time served in months. Cases missing the time served amount and cases where the current sentence was life imprisonment were excluded from the reduction in months calculations.

The percent of time served (REDUCTP) was calculated by dividing the time served by the amount of reduction in months by the most recent sentence, and then multiplying by 100. Cases where the reduction in months was missing or the most recent sentence was life imprisonment were excluded from calculations.
