² The “Percent” column represents, for each Chapter 3 Adjustment, the frequency with which that adjustment was used in the calculation for the specific guideline.

³ Two offenders received a two level enhancement, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

⁴ Two offenders received a one level enhancement for Aggravating Role, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

⁵ Five offenders received a one level decrease for Mitigating Role, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

⁶ One offender received a one level increase, which is less than that provided in the Guidelines. The court determined that this was the proper level. This offender was included in the total.

⁷ Five offenders received a one level decrease for Acceptance of Responsibility, which is less than that provided in the Guidelines, but the court determined that this was the proper level. One offender received a four level decrease, which is greater than provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.
