² The “Percent” column represents, for each Chapter 3 Adjustment, the frequency with which that adjustment was used in the calculation for the specific guideline.

³ One offender received a one level enhancement for Aggravating Role, which is less than that provided in the Guidelines, and two offenders received five levels, which is greater than that provided in the Guidelines, but the court determined that these were the proper levels. These offenders were included in the total.

⁴ Nine offenders received a one level decrease for Mitigating Role, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

⁵ One offender received a one level enhancement for Abuse of Position of trust, which is less than that provided in the Guidelines, and two offenders received four levels, which is greater than that provided in the Guidelines, but the court determined that these were the proper levels. These offenders were included in the total.

⁶ Two offenders received a one level decrease for Acceptance of Responsibility, which is less than that provided in the Guidelines, and one offender received a six level decrease, which is greater than provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.
