Of the 84,173 cases received by the Commission, 74,495 contained complete guideline information (88.5 percent). Of the 86,201 cases received by the Commission, 76,216 contained complete guideline information (88.4 percent). Of the 74,495 with complete guideline calculations, 37 had missing information on the guideline used at sentencing. Fiscal Year 2012 data represents guideline application from guidelines effective November 1, 2011 unless otherwise specified.

<sup>2</sup> The “Percent” column represents, for each Chapter 3 Adjustment, the frequency with which that adjustment was used in the calculation for the specific guideline.

<sup>3</sup> Two offenders received a five level enhancement for Aggravating role, which is greater than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

<sup>4</sup> Nine offenders received a one level decrease for Mitigating Role, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

<sup>5</sup> One offender received a one level enhancement for Abuse of Position of trust, which is less than that provided in the Guidelines, and two offenders received four levels, which is greater than that provided in the Guidelines, but the court determined that these were the proper levels. These offenders were included in the total.

<sup>6</sup> Two offenders received a one level decrease for Acceptance of Responsibility, which is less than that provided in the Guidelines, and one offender received a six level decrease, which is greater than provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.
