¹ The information in this tables depicts information collected from only those cases in which complete guideline information is available. Of the 69,425 cases received by the Commission, 127 were excluded as the defendant was only convicted of 18 U.S.C. § 1028A and another 354 were excluded as the defendant was only convicted of 18 U.S.C. § 924(c). By statute, the punishment for these crimes must be served consecutively to any other punishment, therefore, in these cases the conviction for this crime did not affect the guideline calculation for the underlying offense. Of the remaining 68,944 cases, 64,216 contained complete guideline information (92.5 percent of all cases). An additional 25 cases had missing information on the guideline that controlled the guideline calculation. It is possible to have multiple guideline calculations for each case, and this table represents each guideline calculation for cases in which complete information was received. Fiscal Year 2018 data represents guideline application from guidelines effective November 1, 2016 unless otherwise specified.

² The “Percent” column represents, for each Chapter 3 Adjustment, the frequency with which that adjustment was used in the calculation for the specific guideline.

³ This guideline is effective as of November 1, 2012. There have been zero cases in which this enhancement has been used. This category will not appear in each individual guideline due to the non-use of the enhancement.

⁴ Two offenders received a one level increase for Aggravating Role, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.

⁵ Two offenders received a one level decrease for Mitigating Role, which is less than that provided in the Guidelines, but the court determined that this was the proper level. These offenders were included in the total.
