<sup>1</sup> The information in these tables depicts information collected from only those cases in which complete guideline information is available. Of the 64,142 cases received by the Commission, 90 were excluded as the offender was only convicted of 18 U.S.C. § 1028A and another 361 were excluded as the offender was only convicted of 18 U.S.C. § 924(c). By statute, the punishment for these crimes must be served consecutively to any other punishment, therefore, in these cases the conviction for this crime did not affect the guideline for the underlying offense. Of the remaining 63,691 cases, 61,006 contained complete guideline information (95.1 percent of all cases). An additional 22 cases had missing information on the guideline that controlled the guideline calculation. It is possible to have multiple guideline calculations for each case, and this table represents each guideline calculation for cases in which complete information was received.

<sup>2</sup> The "Percent" column represents, for each Chapter 3 Adjustment, the frequency with which that adjustment was used in the calculation for the specific guideline.
