<sup>1</sup> The information in these tables depicts information collected from only those cases in which complete guideline information is available. Of the 61,678 cases received by the Commission, 63 were excluded as the sentenced individual was only convicted of 18 U.S.C. § 1028A and another 293 were excluded as the sentenced individual was only convicted of 18 U.S.C. § 924(c). By statute, the punishment for these crimes must be served consecutively to any other punishment, therefore, in these cases the conviction for this crime did not affect the guideline for the underlying offense. Of the remaining 61,322 cases, 58,170 contained complete guideline information (94.3 percent of all cases). An additional 10 cases had missing information on the guideline that controlled the guideline calculation.

<sup>2</sup> This “Applied” column represents the number of cases in which each Chapter 3 Adjustment was applied within the primary sentencing guideline calculation.

<sup>3</sup> The “Percent” column represents, for each guideline, the portion of all cases in which the Chapter 3 Adjustment was applied within the primary sentencing guideline calculations.
