¹ The information in these tables depicts information collected from only those cases in which complete guideline information is available. Of the 66,662 cases received by the Commission, 61,245 contained complete guideline information (91.9% of all cases). By statute, sentences for violations of 18 U.S.C. § 924(c) and 18 U.S.C. § 1028A must be served consecutively to any other punishment; therefore, in those cases the conviction for these crimes did not determine the sentencing guideline applied. In 46 cases the individual was convicted of 18 U.S.C. § 1028A only and in another 252 cases the individual was convicted of 18 U.S.C. § 924(c) only. For this report, those cases are treated as missing guideline information and excluded. An additional six cases were missing information on the guideline that controlled the guideline calculation. Guidelines and guideline subsections with incomplete guideline application information are excluded.

² This “Applied” column represents the number of cases in which each Chapter 3 Adjustment was applied within the primary sentencing guideline calculation.

³ The “Percent” column represents, for each guideline, the portion of all cases in which the Chapter 3 Adjustment was applied within the primary sentencing guideline calculations.
