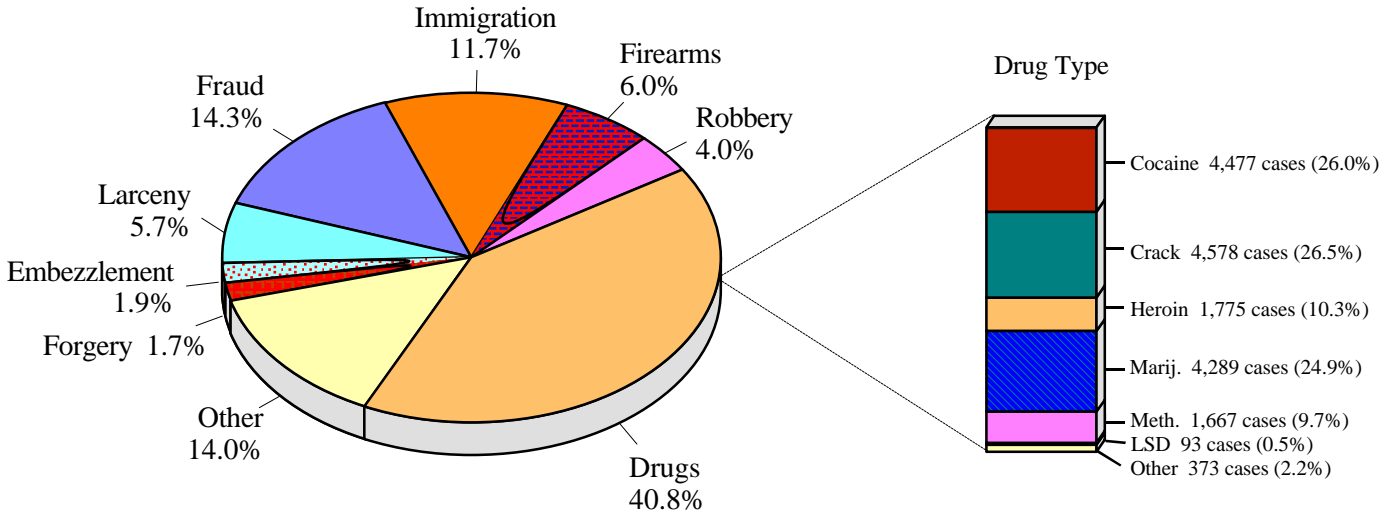


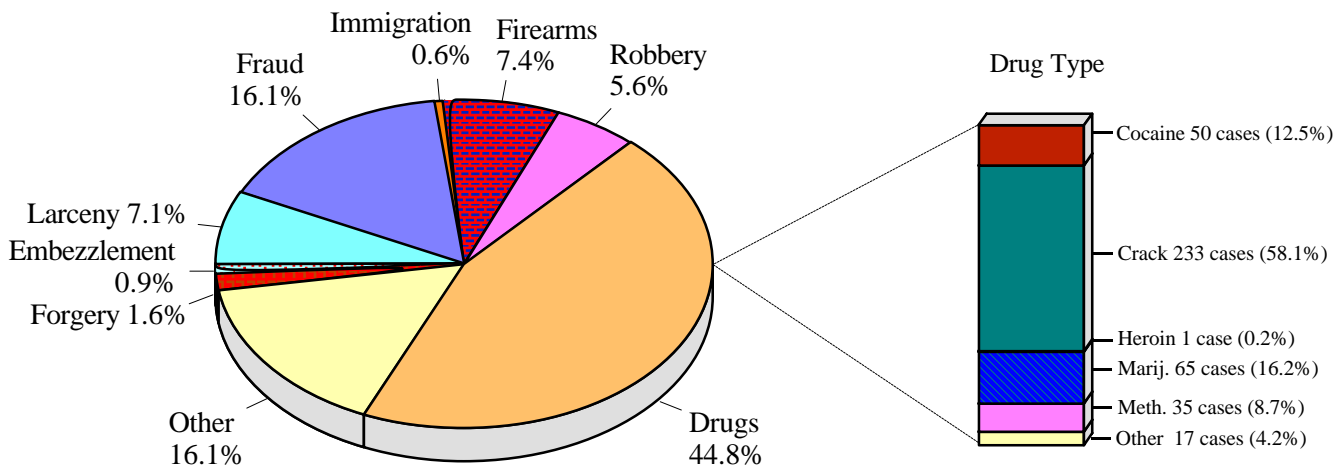

Of the 42,436 guideline cases, 8,615 cases with zero months prison ordered were excluded. In addition, 370 cases were excluded due to one or both of the following reasons: missing primary offense category (74) or missing or indeterminable sentencing information (330).

Of the 899 guideline cases from the State of Alabama, 200 cases were excluded due to one or more of the following reasons: zero months prison ordered (195), missing primary offense category (2), or missing or indeterminable sentencing information (4).
