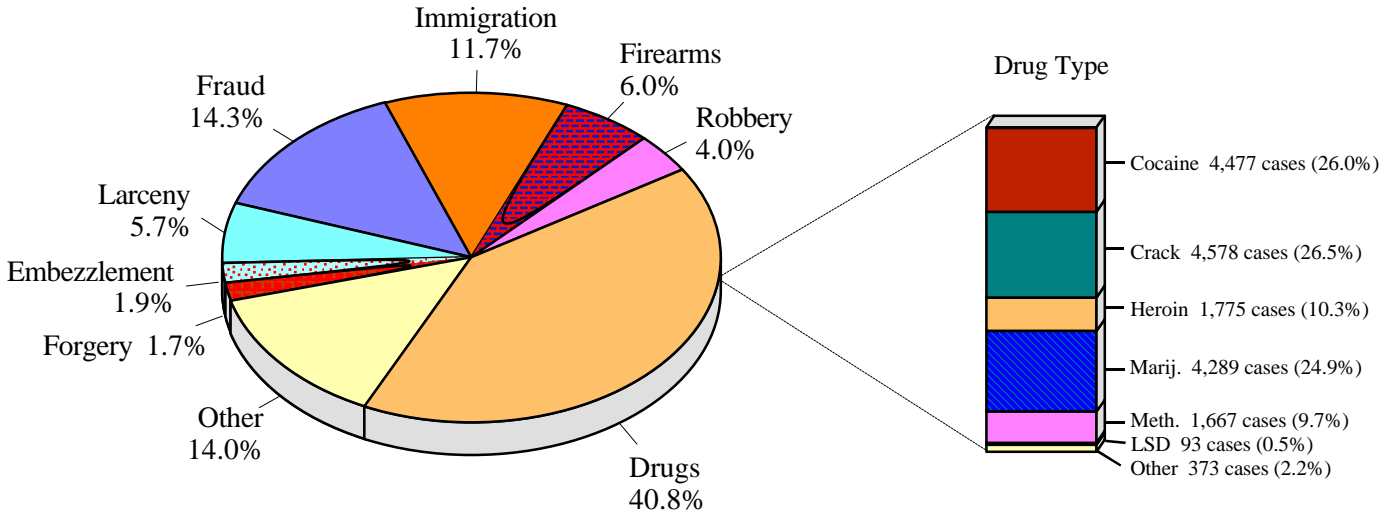


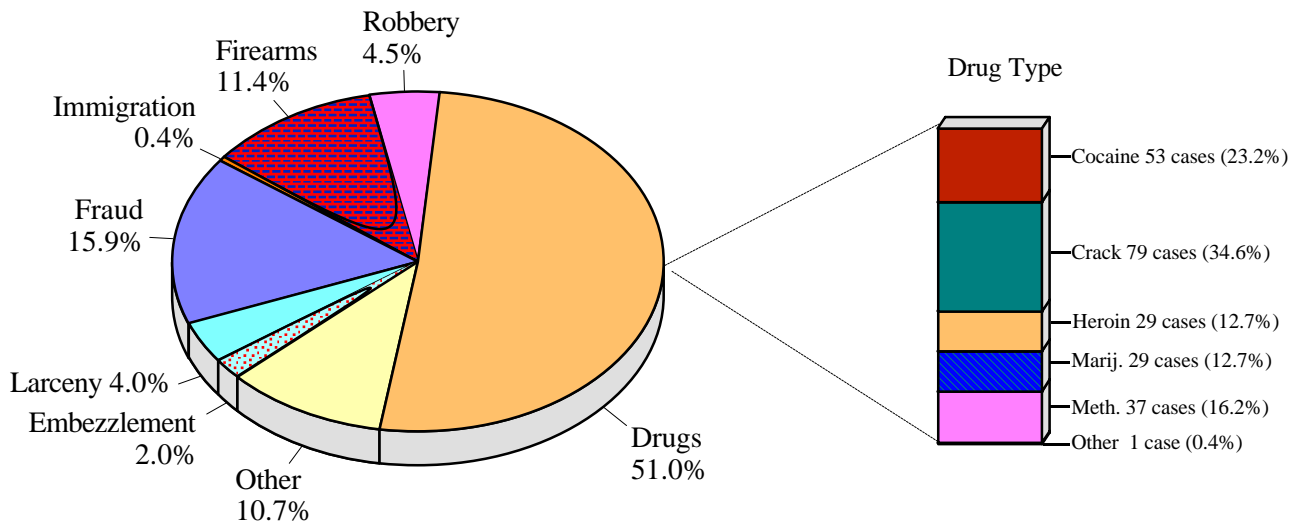

Of the 447 guideline cases from the District of Missouri, Eastern, 77 cases with zero months prison ordered were excluded.
