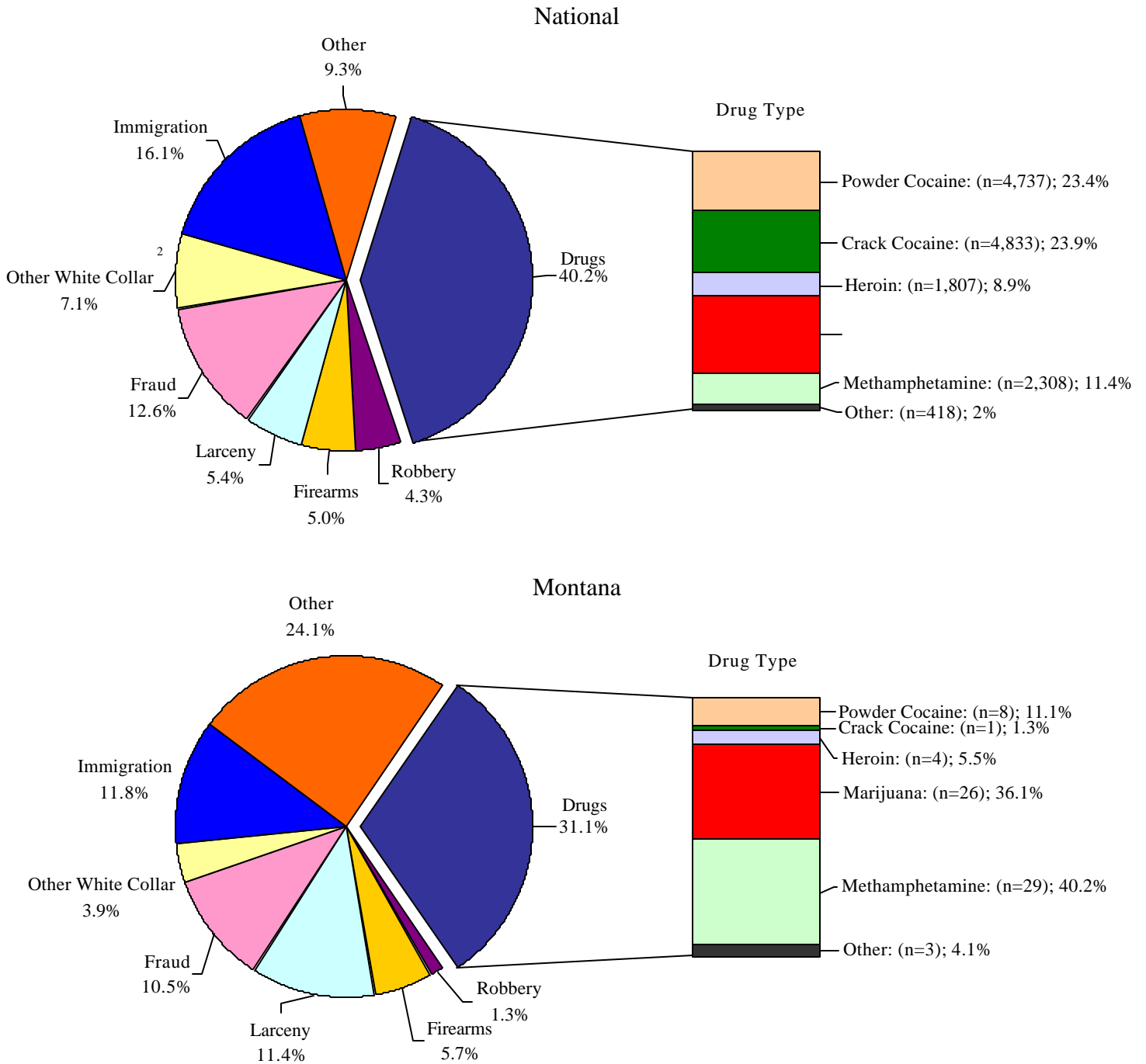

Of the 50,754 guideline cases, 8,803 cases with zero months prison ordered were excluded. In addition, 771 cases were excluded due to one or both of the following reasons: missing primary offense category (149) or missing or indeterminable sentencing information (677).

Of the 231 guideline cases from the District of Montana, 75 cases with zero months prison ordered were excluded. In addition, nine cases were excluded due to one or both of the following reasons: missing primary offense category (1) or missing or indeterminable sentencing information (8).
