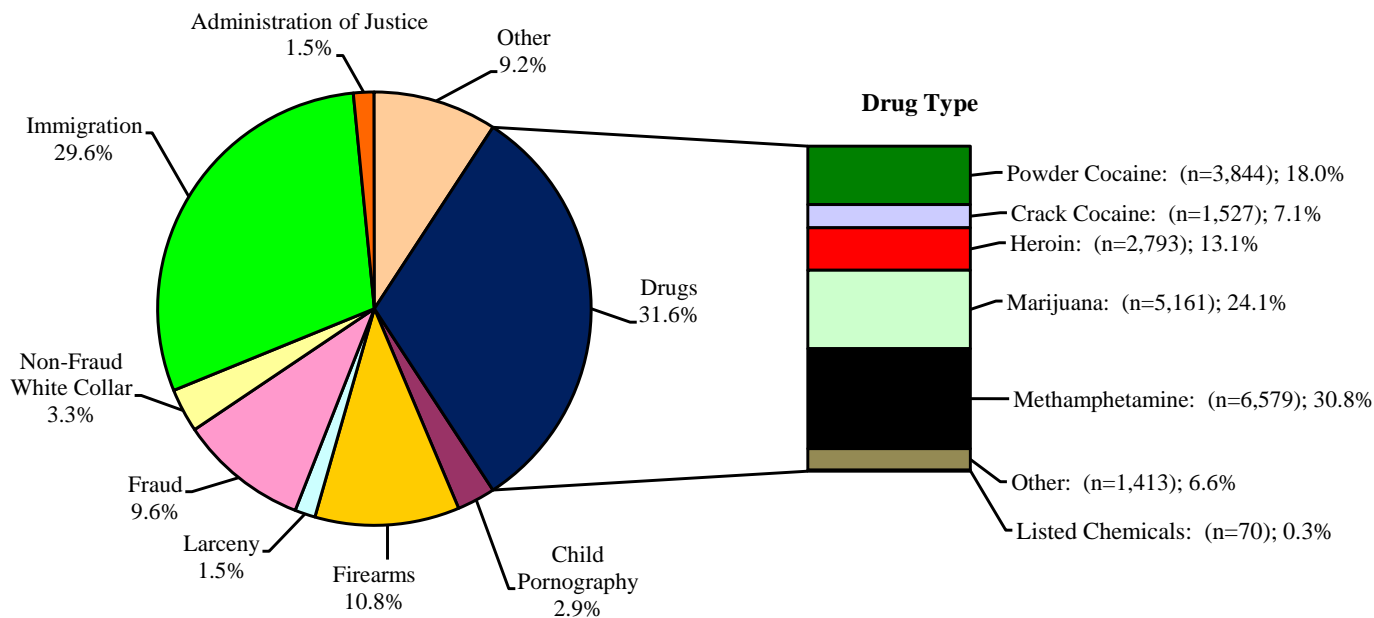

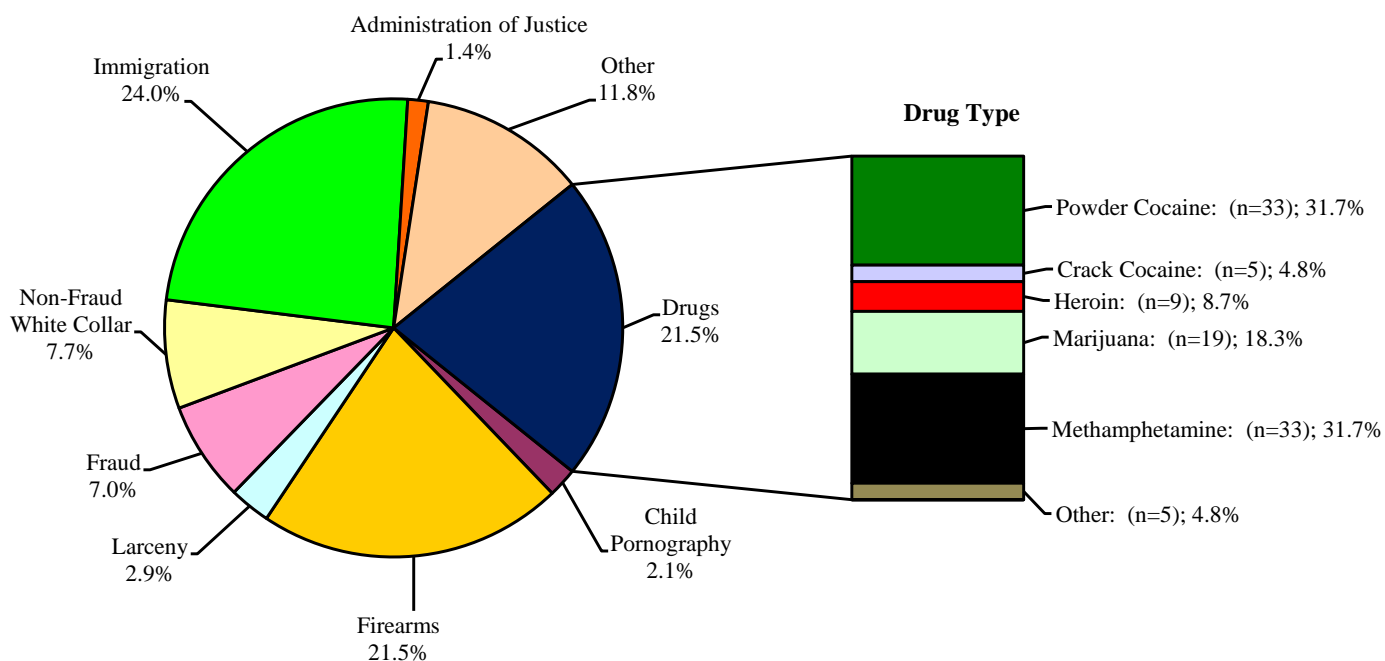

Of the 483 guideline cases from the District of Colorado, one case was excluded because information was missing from the from the submitted documents that prevented the comparison of the sentence and the guideline range.
