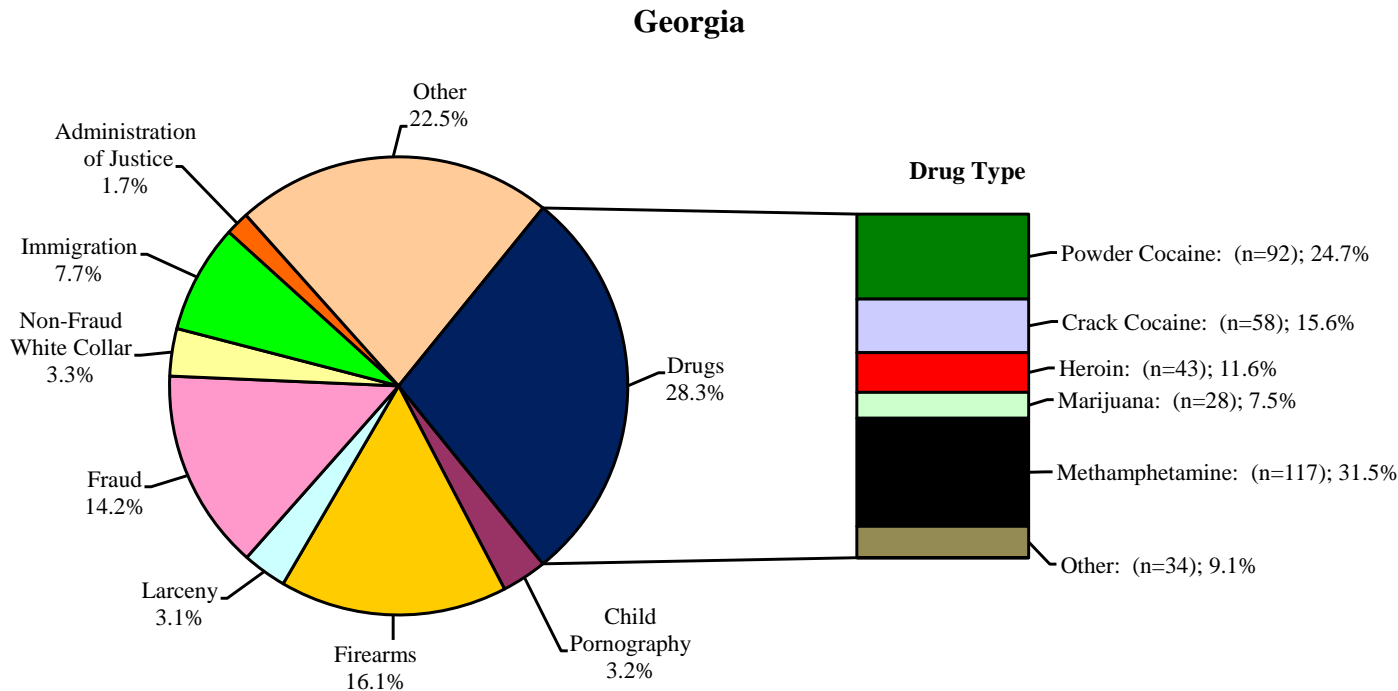
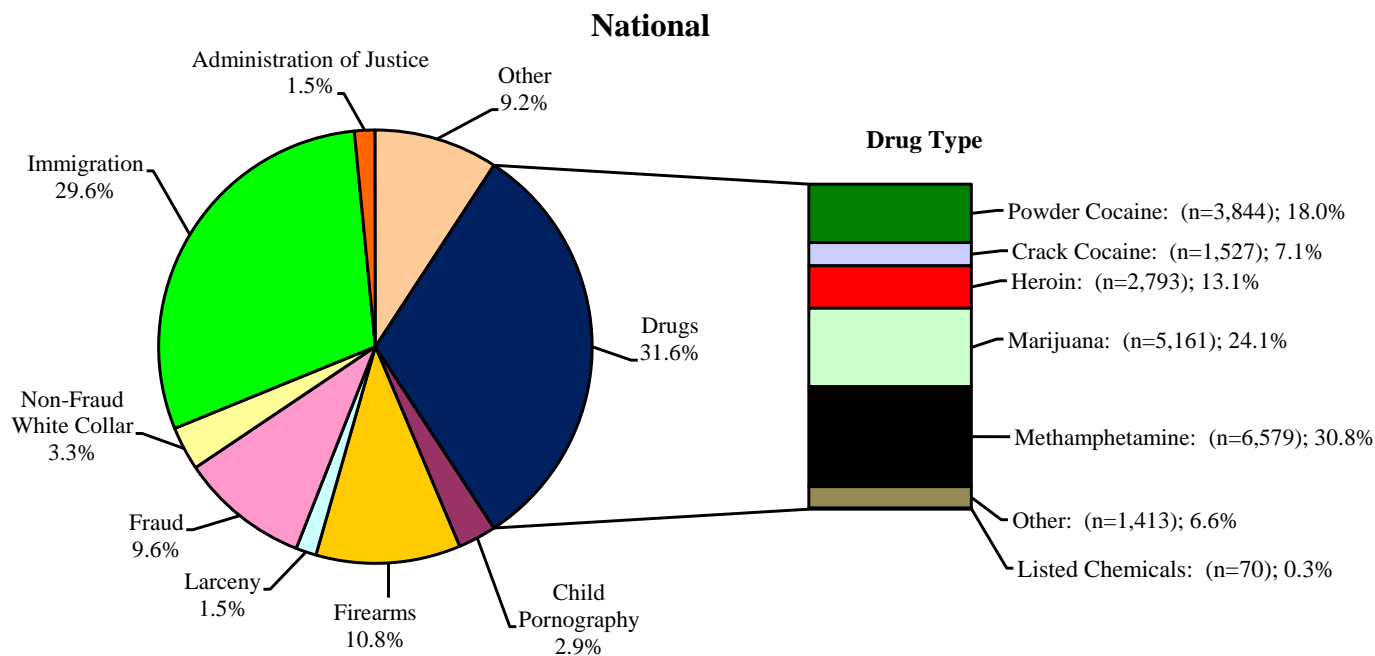

Of the 1,314 guideline cases from the State of Georgia, a U.S. Citizen was the defendant in 1,035 cases. Of these, 861 cases were excluded because the defendant was ineligible for a non-prison sentence.
