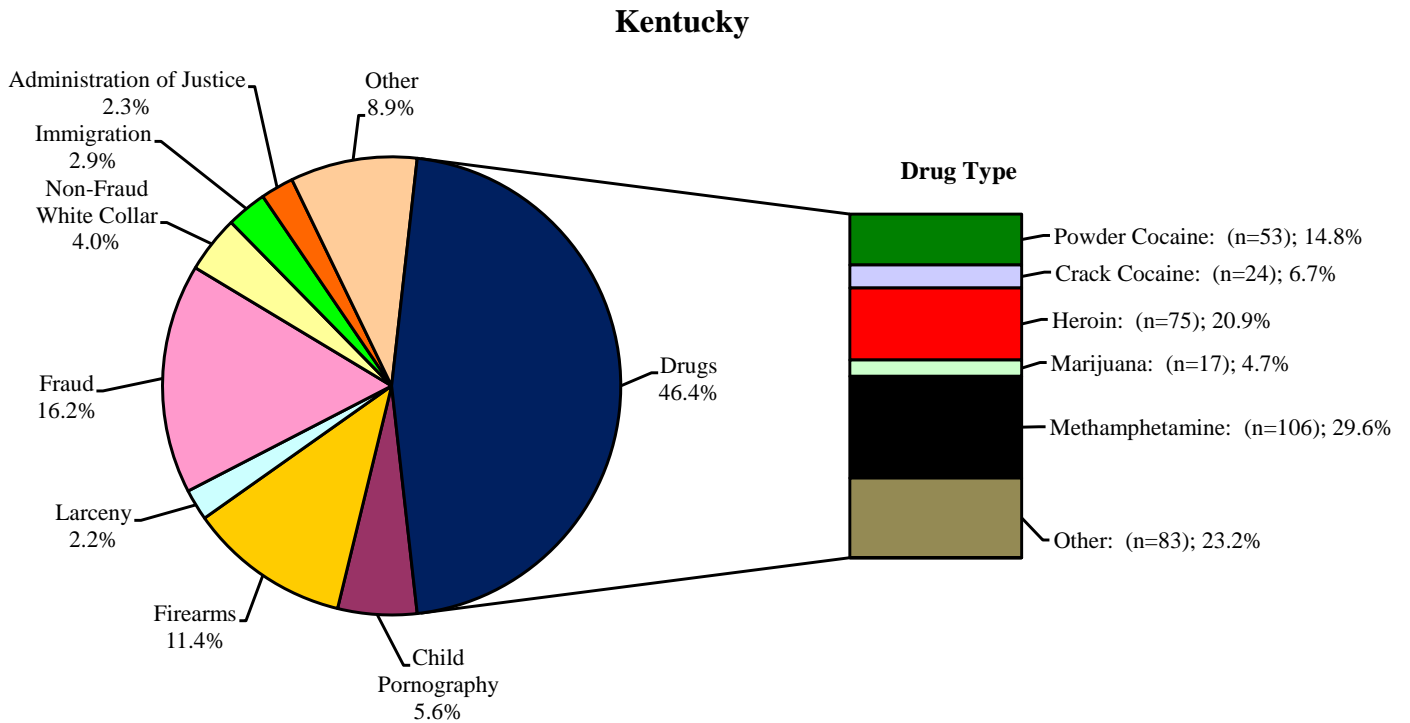
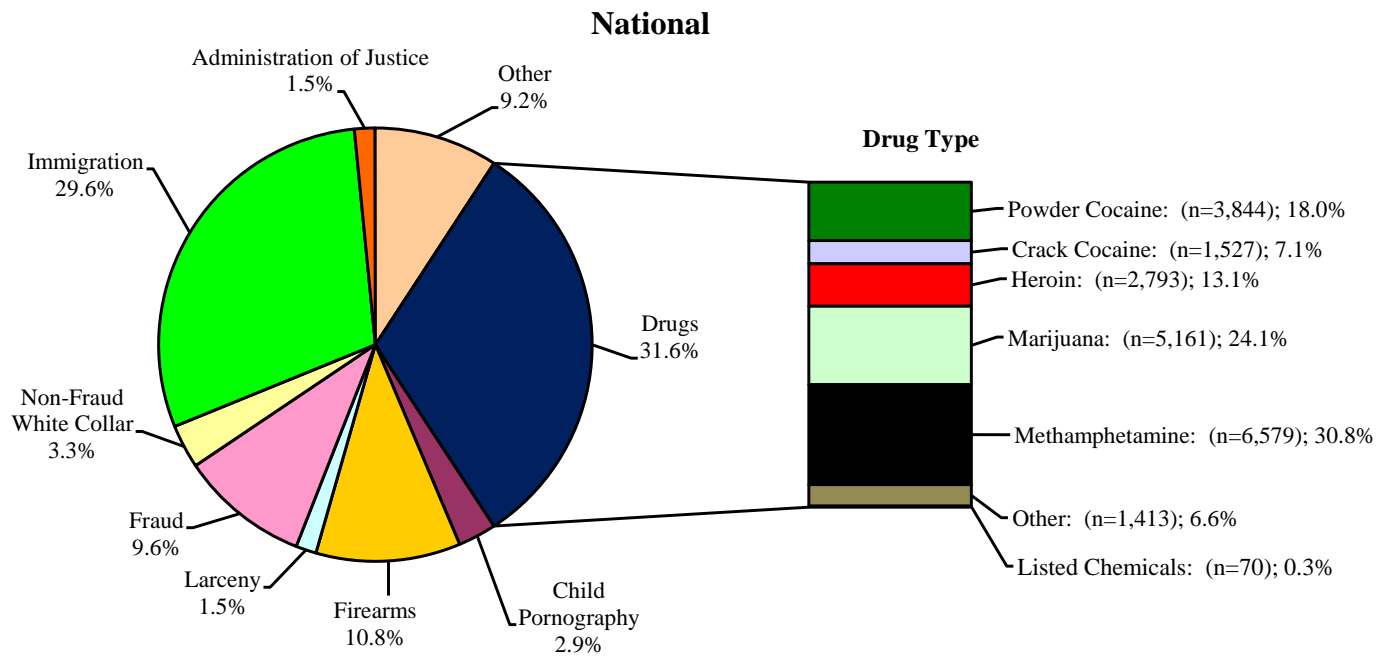

Of the 771 guideline cases from the State of Kentucky, a U.S. Citizen was the defendant in 658 cases. Of these, 571 cases were excluded because the defendant was ineligible for a non-prison sentence.
