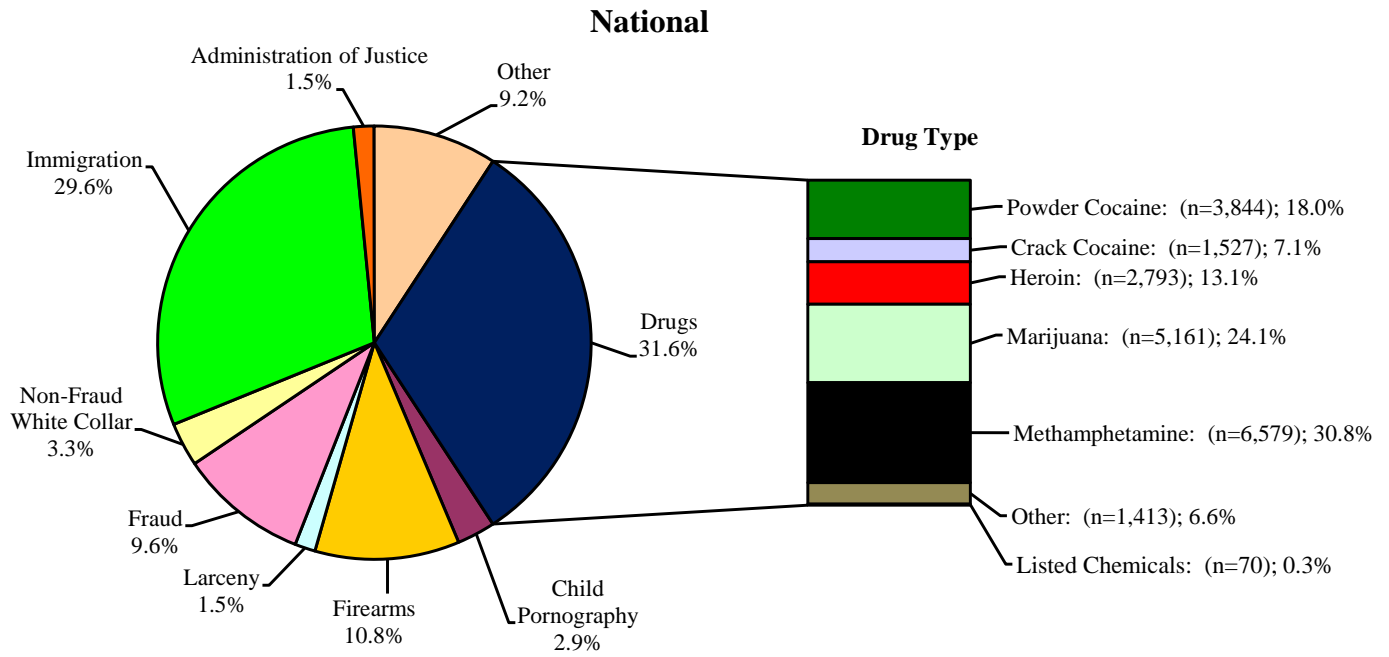

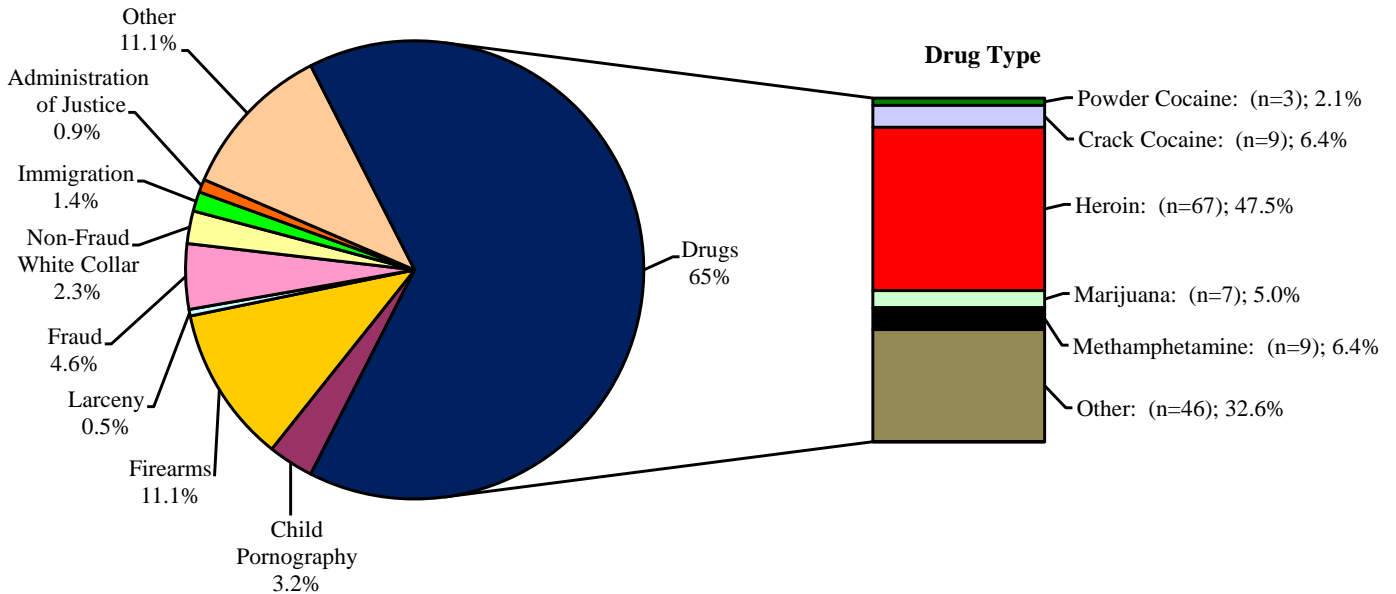

Of the 217 guideline cases from the Southern District of West Virginia, a U.S. Citizen was the defendant in 207 cases. Of these, 185 cases were excluded because the defendant was ineligible for a non-prison sentence.
