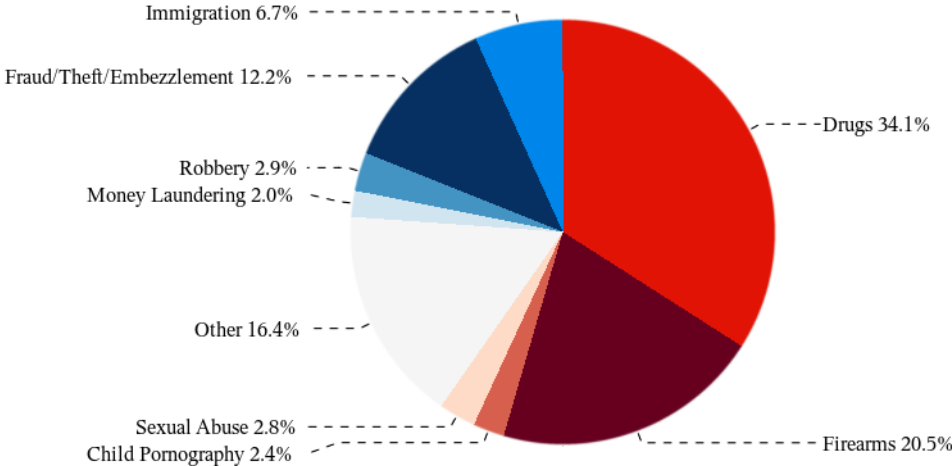

The Fourth Circuit figure includes the 4,183 cases reported to the Commission.

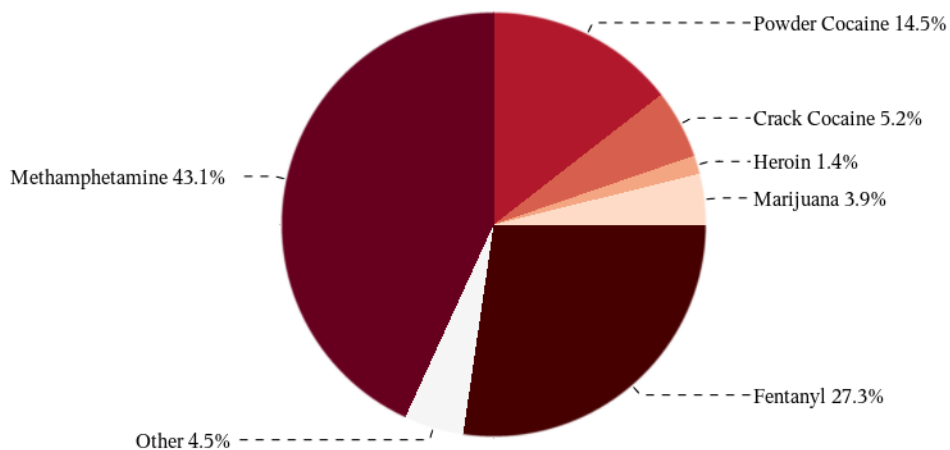

Of the 66,662 National cases, in 16,234 the individual was sentenced under USSG Chapter Two, Part D (Drugs).

Of the 4,183 cases from the Fourth Circuit, in 1,412 the individual was sentenced under USSG Chapter Two, Part D (Drugs).

An additional 13 drug possession cases were reported from the Fourth Circuit without guideline information. The primary drug type in those cases was cocaine (3), fentanyl (2), methamphetamine (1), heroin (1), and other (1).
