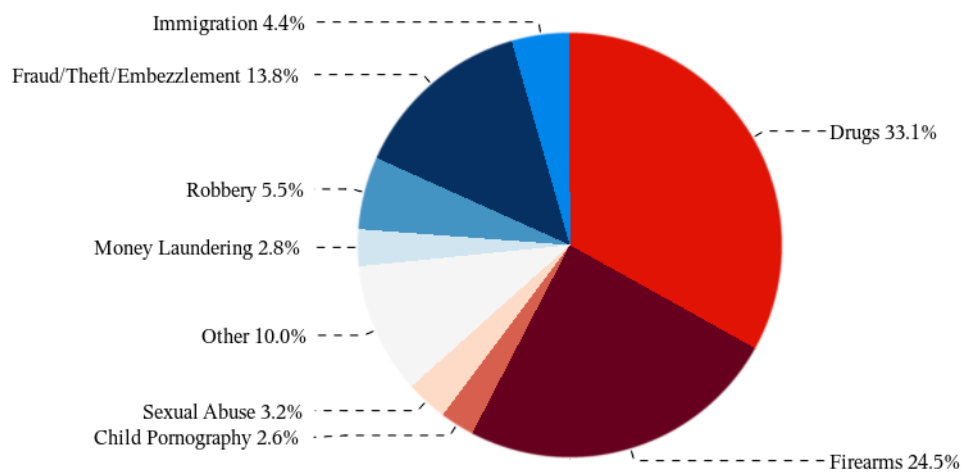

The Seventh Circuit figure includes the 2,111 cases reported to the Commission.

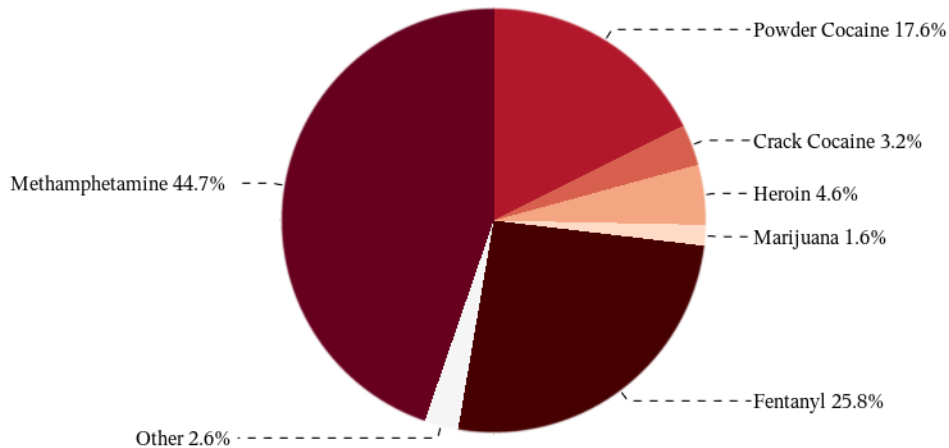
