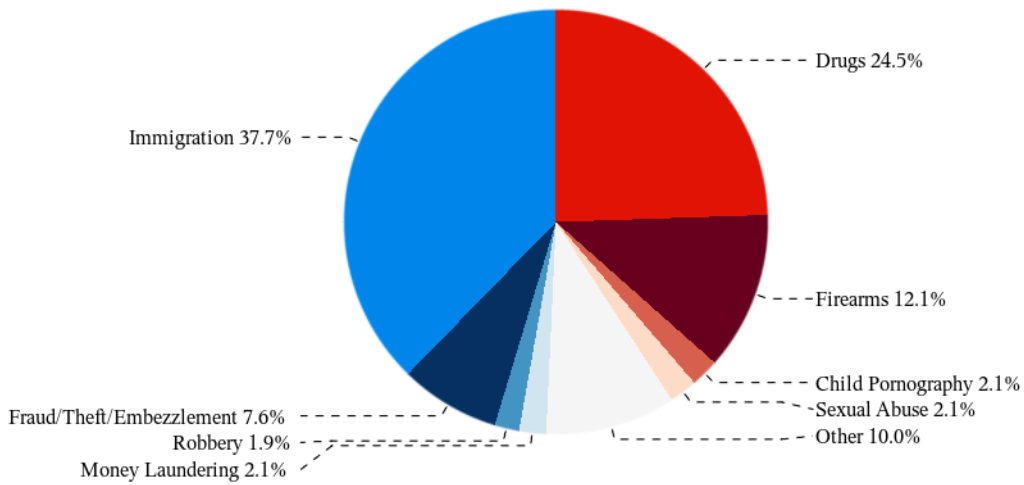

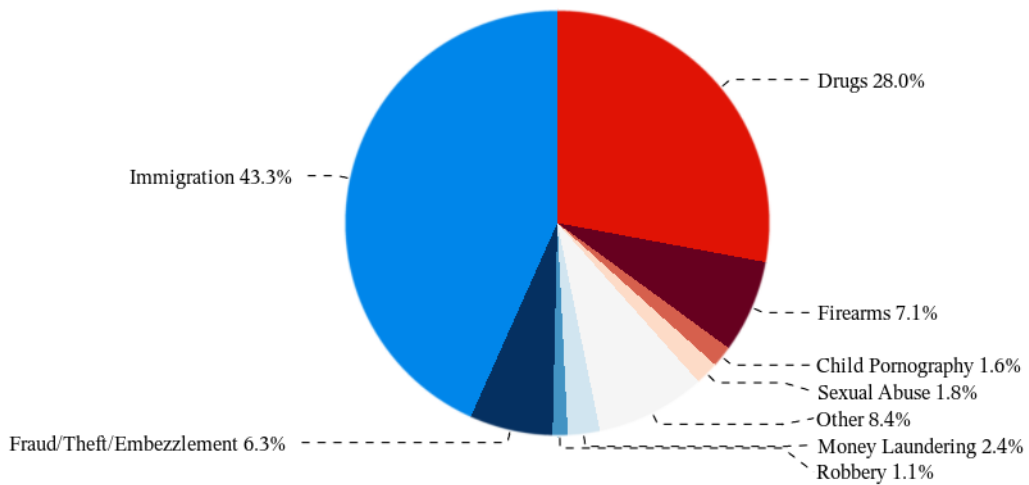

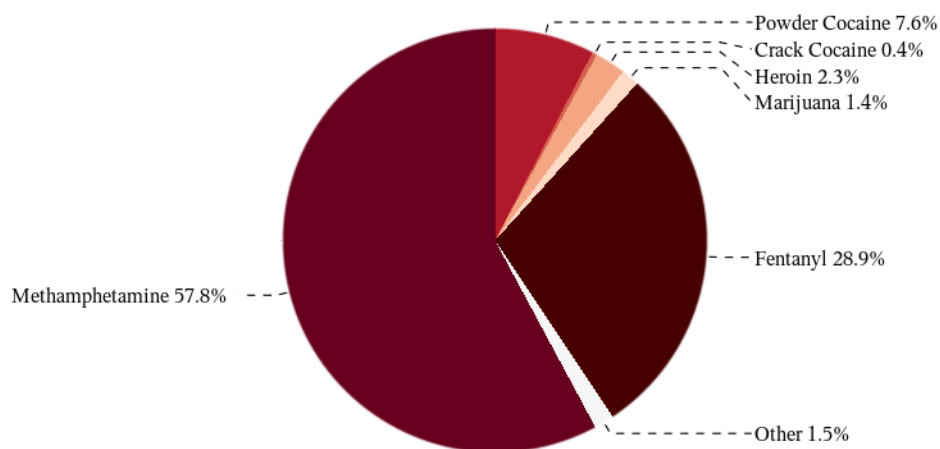

Of the 66,662 National cases, in 16,234 the individual was sentenced under USSG Chapter Two, Part D (Drugs).

Of the 10,991 cases from the Ninth Circuit, in 3,025 the individual was sentenced under USSG Chapter Two, Part D (Drugs).

An additional 17 drug possession cases were reported from the Ninth Circuit without guideline information. The primary drug type in those cases was methamphetamine (10), fentanyl (4), marijuana (2), and crack cocaine (1).
