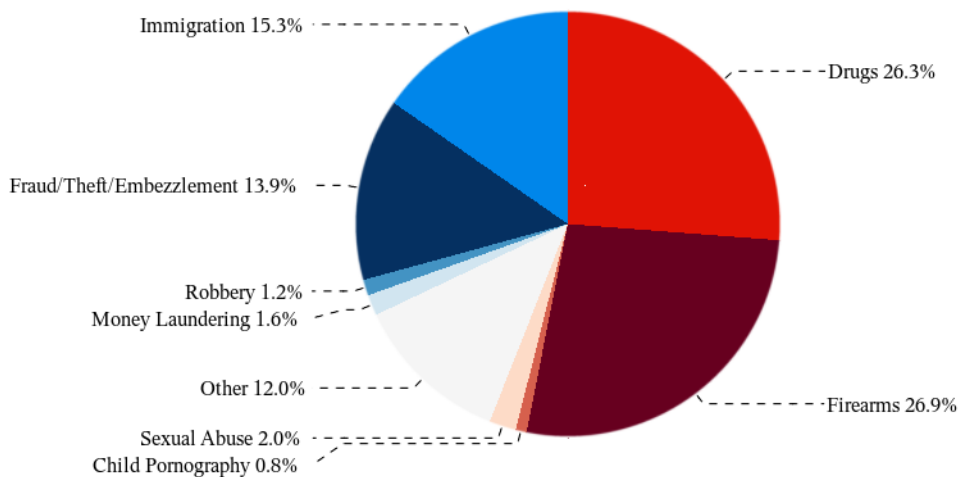

The State of Alabama figure includes the 1,078 cases reported to the Commission.

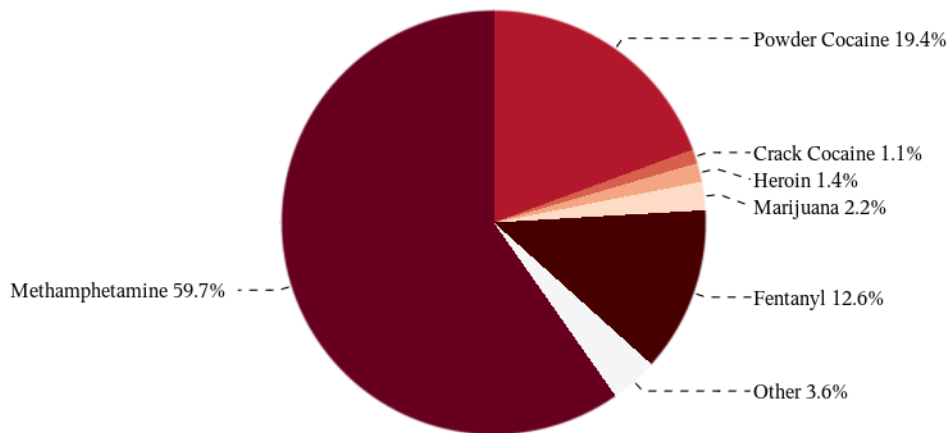
