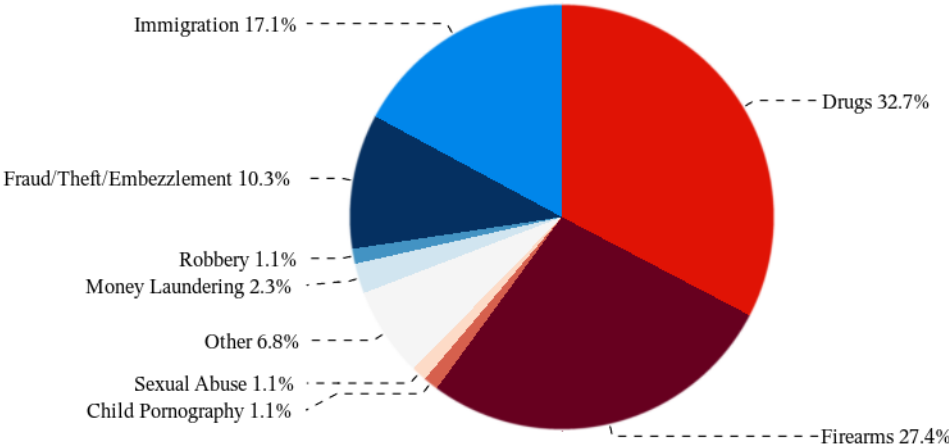

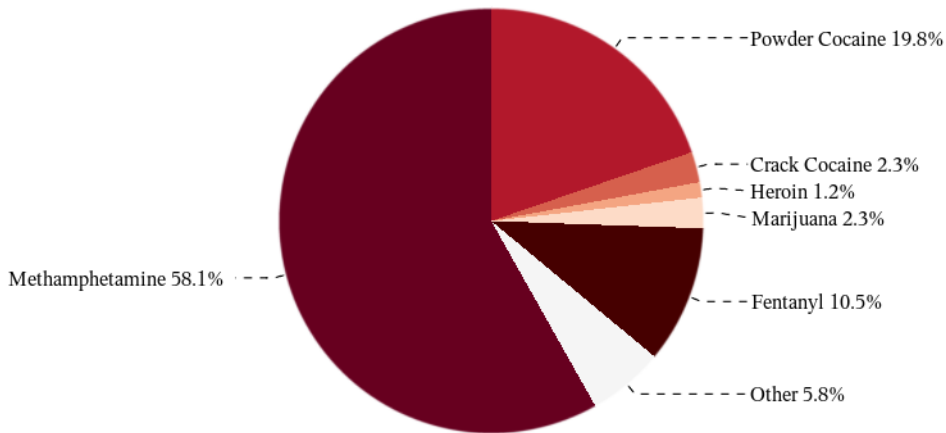

Of the 66,662 National cases, 626 were excluded because information was missing from the submitted documents that prevented the comparison of the sentence and the guideline range.

Of the 263 cases from the Middle District of Alabama, no cases were excluded.
