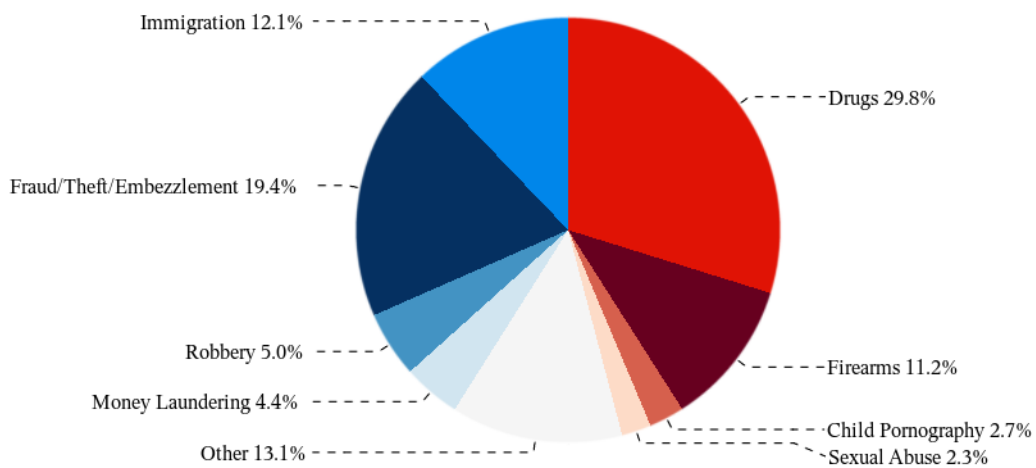

The Central District of California figure includes the 932 cases reported to the Commission.

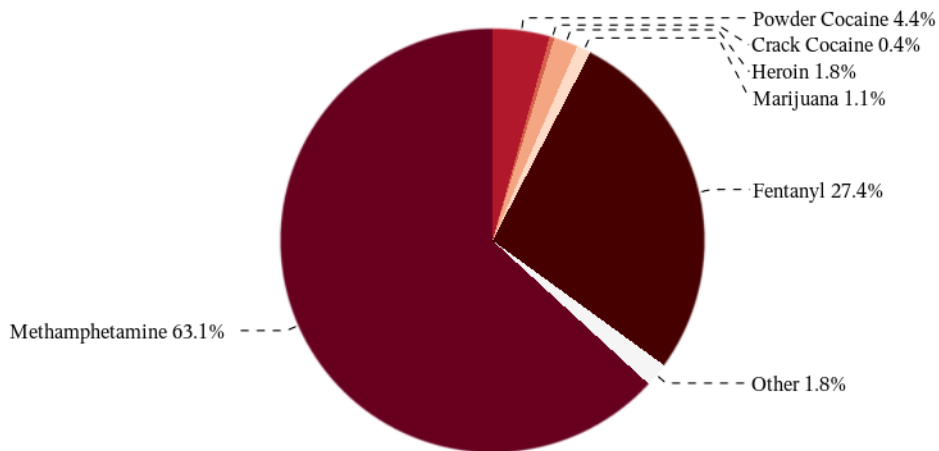
