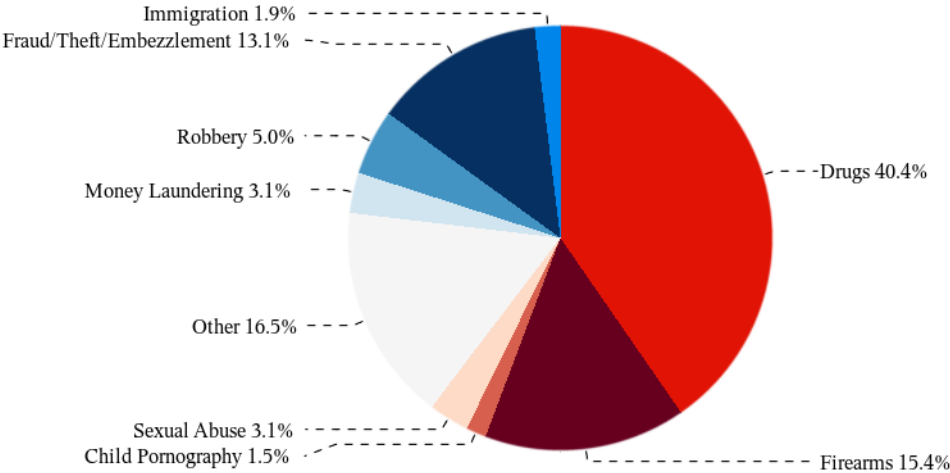

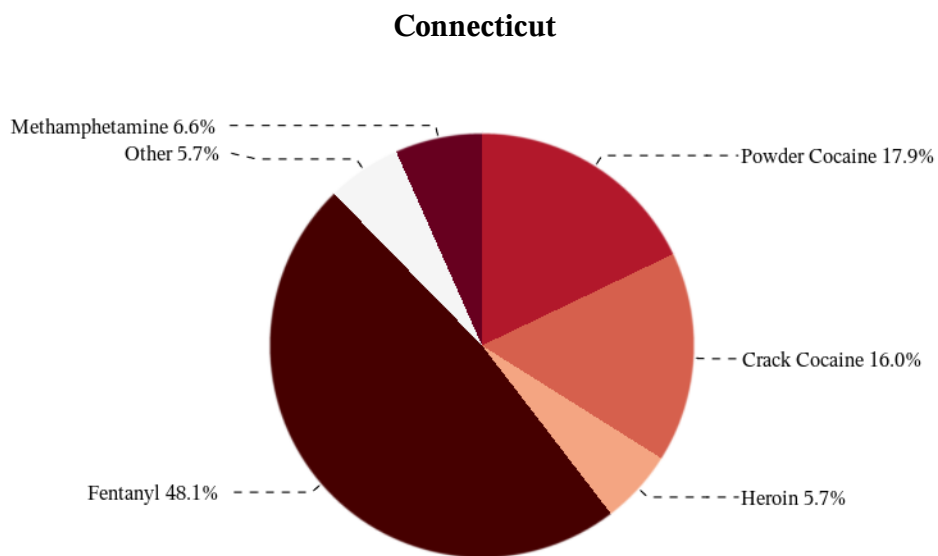
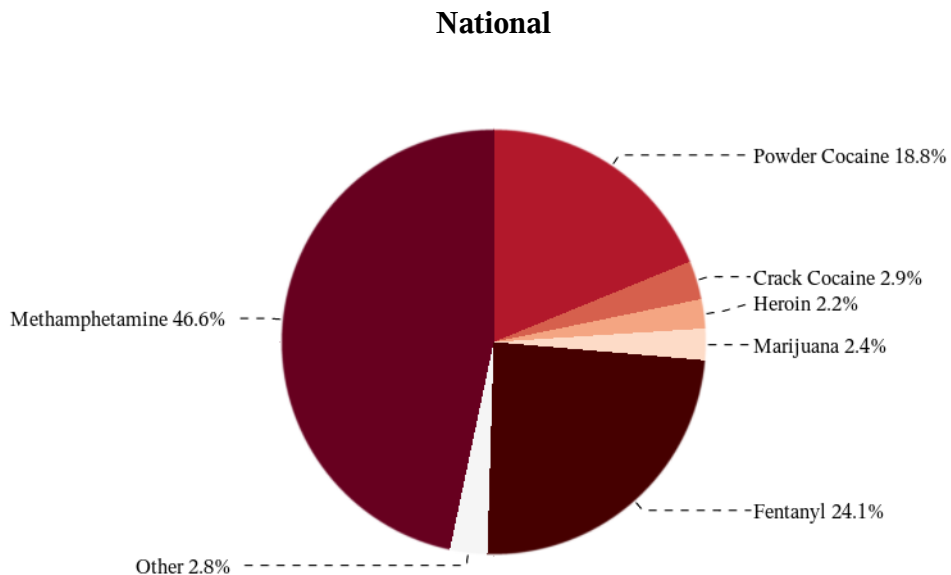

Of the 66,662 National cases, a U.S. Citizen was the sentenced individual in 37,373 cases. Of these, 33,403 cases were excluded because the sentenced individual was ineligible for a non-prison sentence.

Of the 260 cases from the District of Connecticut, a U.S. Citizen was the sentenced individual in 233 cases. Of these, 226 cases were excluded because the sentenced individual was ineligible for a non-prison sentence.
