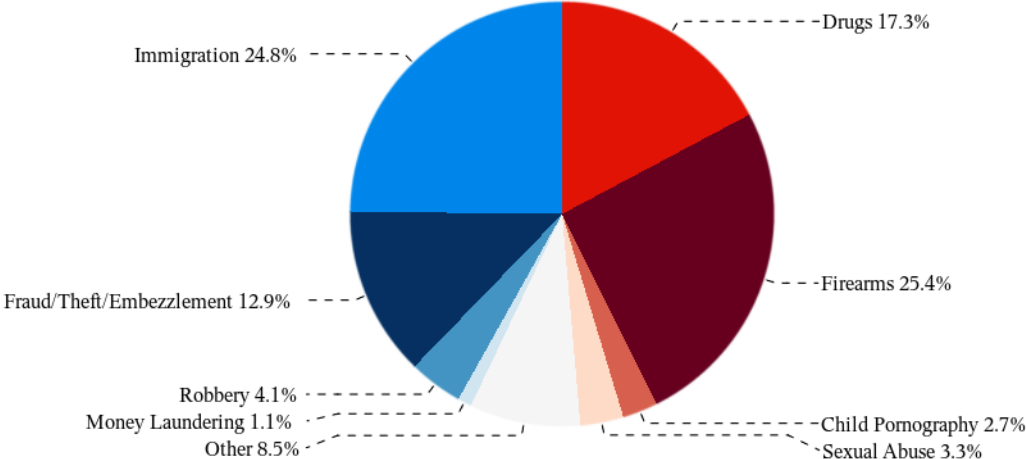

**Eastern Michigan**



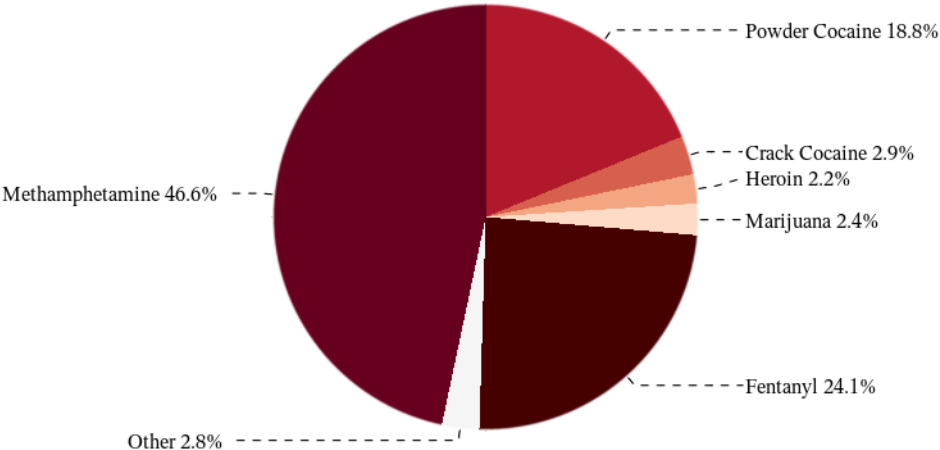

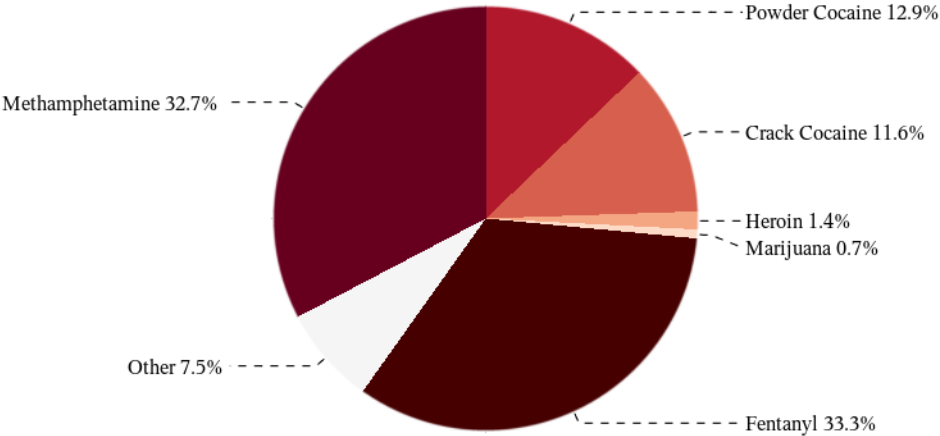

Of the 66,662 National cases, a U.S. Citizen was the sentenced individual in 37,373 cases. Of these, 33,403 cases were excluded because the sentenced individual was ineligible for a non-prison sentence.

Of the 851 cases from the Eastern District of Michigan, a U.S. Citizen was the sentenced individual in 616 cases. Of these, 588 cases were excluded because the sentenced individual was ineligible for a non-prison sentence.
